State of North Carolina District of Edenton

Perquimans County Superior Court of Law

Jacob Lane, in order to avail himself of the privileges of the late act of Congress entitled an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war, appeared before me the 12th day of April in open Court and made oath, that on or about the middle of May 1777, he entered in the company commanded by Captain Isaac Moore, in the Regiment commanded by Colonel Shepperd in the Continental line of the State of North Carolina, to serve 3 years; that he did serve for 3 years in succession, but that at the end of the period of service he was detached by Colonel Lytle, on some private service, & that he never received his discharge, although he was duly entitled thereto & the said Jacob Lane further states that he is in reduced circumstances & requires the aid of his country.

Be it further remembered, that at the time & place above mentioned, personally appeared before me judge aforesaid, John Rogerson<sup>1</sup> of the County & State aforesaid, who being duly sworn, deposeth & saith that he knows of his own knowledge, the fact of the enlistment & service of the said Jacob Lane, as mentioned in his preceding statement, that he served in the Continental line of the State of North Carolina for 3 years, as he has stated, & that he believes he is in reduced circumstances.

I William Hill Secretary of State in & for the State aforesaid do hereby certify that it appears from the musterroll of the North Carolina Continental line in the Revolutionary war that Jacob Lane a Corporal in Captain Moore's company of the 10th Regiment was mustered on the 2nd of August 1777 for 3 years, that he was a private in June 1778 nothing further is said of him.

State of North Carolina District of Edenton: Superior court before Perquimans County

On this 11th day of April 1819, before me, the subscriber, one of the Judges of the Superior or Circuit Courts of North Carolina for the said district, personally appeared Jacob Lane aged 72 years, resident in Perquimans County in said district, who, being by me first duly sworn,

according to law, doth, on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress, entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war." That he, the said Jacob Lane enlisted for the term of three years on the \_\_\_ day of May in the year 1777 and Perquimans County in the State of North Carolina in the company commanded by Captain Isaac Moore of the Regiment commanded by Colonel Shepperd in the line of the State of North Carolina on the Continental Establishment; that he continued to serve in the said corps, or in the service of the United States, until about the 20th May 1780, when he was discharged from the service in the State of South Carolina, that he was in the battles of Monmouth in New Jersey and in the Siege of Charleston (SC) where he was taken prisoner, and that he is in reduced circumstances, and stands in need of the assistance of his country for support; and that he has other evidence now in his power of his said services which is here with annexed. On this 15th day of May 1821 personally appeared in open Court, Being a court of record for the County of Perquimans Jacob Lane of the said County aged seventy-five years -- Resident in the said County who being first duly sworn according to law doth on his oath declare that he served in the revolutionary war as follows -- say seven years & three months -- and was in the battle of Monmouth, White Plains and at the Siege of Charleston & taken prisoner -- (and I also solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

I further swear that I received a pension Certificate No. 13 482 and dated April the 11th 1819. That I am by occupation a farmer. That both my hands are somewhat disabled, the fingers of both being in some measure shot -- and that I am moreover very badly ruptured in both groins -- That I am a widower and have six children of the following names & ages -- Delila aged 18, Nancy 14, Amos 9, Gilley 7, Jefferson 5, Benbury 3 years of age all of whom live in my family except Delila -- that are dependent on me for a support.
