
[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The State of Ohio Clermont County: Be it remembered that on the 5th day of June 1818 came personally before me Alexander Blair a Judge of the Court of Common Pleas in and for said County Hezekiah Lindsey aged Seventy-one years and being duly sworn on the Holy Evangelist deposed and saith he enlisted in the Army of the United States in the County of Westmoreland and State of Pennsylvania in the Company commanded by Captain Uriah Springer in the ___ Regiment commanded by Colonel John Gibson in the Virginia line on Continental Establishment that he served in the American Army three years the full time he had enlisted for, that he obtained his discharge from the Army at Fort Pitt now Pittsburgh Pennsylvania that some years after the War he transmitted his said discharge to the State of Virginia to obtain his land Warrant but that he never obtained any land for his services. The deponent offers the annexed deposition of Andrew Chalmers as evidence that he never has obtained any Pension and hereby relinquishes every pension heretofore allowed by the Laws of the United States – Hand this deponent the said Hezekiah Lindsey on his oath aforesaid declares that from his reduced circumstances he needs the assistance of his Country for Support.

State of Ohio Clermont County: On this 5th day of June 1818 came personally before me Alexander Blair a Judge of the Court of Common Pleas within and for said County Andrew Chalmers¹ and being duly sworn according to law deposed and saith that he saw the above named Hezekiah Lindsey at Fort Pitt in the State of Pennsylvania in the year 1780 that he traveled having obtained a furlough with him while both of them were on their way home about 40 miles that he this deponent understood and does verily believe that the said Hezekiah had served in the American Army of the revolution against the Common Enemy.

The State of Ohio Clermont County: SS

On the 8th day of June 1820 personally appeared in open court (being the Court of Common Pleas within and for said County and also being a Court of record, which have the power of fine and imprisonment[)], Hezekiah Lindsey aged 73 years, resident in the said County,

who first being duly sworn, according to law, doth on his oath declare that he served in the revolutionary War as follows, to wit in the 9th Regiment commanded by Colonel John Gibson in the Company commanded by Captain John Springer in the Virginia line and that he was notified of his being inscribed on the pension list roll of the Ohio agency at \$8 per month commencing on the 5th day of June 1818 by a pension certificate No. 11613 bearing date 7th June 1819 & I do solemnly swear, that I was a resident citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled “an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war” passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed, to wit, real estate none one cow, five bee hives and he is a daily laborer but owing to age and infirmity is unable to work but a small part of the time, & that he has no family, but himself.

The State of Ohio Brown County

On the 6th day of May 1819 came personally before me the subscriber a Justice of the Peace in and for said County Patrick Grogran² a respectable witness and being duly sworn on the Holy evangelists doth depose declare and say that he this deponent was a Soldier in the War of the Revolution in the ___ Regiment commanded by Colonel Gibson in the Virginia line on Continental establishment. And that he was and now is acquainted with Hezekiah Lindsey who resides in the County of Clermont in the State aforesaid and that the said Hezekiah Lindsey was an enlisted Soldier in the American Army of the Revolution and that the said Hezekiah did serve as a Soldier in the Army aforesaid for more than nine months at one time and this deponent verily believes that the said Hezekiah did serve in the same Army for about three years the whole time that he enlisted for – And further this deponent saith not

[Veteran was pensioned at the rate of \$8 per month commencing June 5th, 1818, for service as a private for 3 years in the Virginia Continental line.]
