[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Assistant Surgeon Continental Hospital Southern Department Sept. 1776 to 1782

District of Pennsylvania SS }

On this twenty Seventh day of March A.D. 1818 before me Richard Peters Judge of the District Court of the United States in and for the Pennsylvania District personally appeared John Lochman at present residing in the Alms House [almshouse] of the City and County of Philadelphia who being duly sworn upon the Holy Evangelist of Almighty God, deposes and declares that during the War of the Revolution he served in the Continental Army in the South Carolina Line thereof, in the Capacity of an Assistant Surgeon; that he received his Commission as such in the month of September 1776 and served therein during six years or thereabouts until discharged on the reduction of the Army in the year 1782, a few months before the conclusion of Peace between the United States and Great Britain. That in the course of such service and in the performance of the duties arising out of it he incurred diseases and disabilities which have not ceased to afflict him during a long course of years, and by incapacitating him for any active exertions have reduced him to circumstances of indigence and distress and rendered him for a long time past and at present "in need of assistance from his Country for support." And this Deponent further declares that he does not at present receive and never has received or been allowed any pension by the laws of the United States or of any State thereof.

¹ The reason there are no surviving papers relating to this bounty land claim is that the offices of the War Department along with the papers filed there were destroyed by fire in 1800 and all pension and bounty land records predating that fire were destroyed. Further, pension and bounty land papers generated between the fire of 1800 and 1814 were lost when the British burned Washington DC on August 14, 1814.

That they remember him in the said service in 1779 & the said W. S. Stevens and John E. Poyas know that he continued in it to the End of the War. The said W. S. Stevens, John E. Poyas and Simeon Theus further depose that the said John Lochman after the War was a Member of the Society of Cincinnati.



To the Honorable John Lloyd Esquire and the rest of the Honorable the Senate

The Memorial of John Lochman late Junior Surgeon in the Hospital Department of this State

humbly Sheweth

That by a resolve of the United States in Congress assembled, the Officers of the late American Army were entitled to half pay during life; that afterwards that August Body, found it expedient to commute the same, and instead thereof to furnish them with five years full pay.

That for reasons unknown to your Memorialist, the Junior Surgeons, were not included in the Resolve but after having devoted to the Service, the same time that others of superior rank did, they were discharged from the Army of the United States, without anything in hand to provide for their future support. That the other Junior Surgeons sent a Petition to your Honorable House praying for such relief as might appear necessary men on the 21st February 1785 the House, in consideration of the Justice due to them, were pleased to resolve that commutation should be allowed them.

That your Memorialist is a Foreigner very little acquainted with the English Language and having but small acquaintance with others of the same Grade, so that the justice and Liberality which your Honorable House was pleased to extend to his Grade, was totally unknown to him, till the time expired, when his Claims ought to have been carried before the Auditor, that the Auditor does not think himself authorized now to pass his Accounts.

Your Memorialist therefore prays that your Honours will take his peculiarly hard case into consideration, and that you will not suffer his want of information, to exclude him from that which with Submission he thinks justly due to him, but that your Honours will be pleased to give such relief as the case requires.

And your Memorialist as in Duty bound will ever pray.


