Pension application of Malcolm McClellan S5070

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

North Carolina Cumberland County: Special Court of the Court of Pleas and Quarter Sessions for Cumberland County

On this day (to wit) on the 31st of December A.D. 1832 personally appeared before us Gordon Deminy, Dolphin A. Davis, Warren Winslow acting justices of the peace for said County and holding a special Court for that purpose – Malcolm McClellan aged about 77 years of age, who first being duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832. That he is a resident of Cumberland County and State aforesaid – That he enlisted in the service of the Colonies in the month of October A.D. 1775 – Under Cpt [Captain] Robt Rowan [Robert Rowan], Hector McNeill Lieutenant and one Neill McAllister Ensign – that he enlisted in Cumberland County, and marched to Cross Creek now Fayetteville, from thence to Wilmington, from thence to Brunswick then to Fort Johnson – where one Lieutenant Moore was accidentally killed by a sentinel – from thence he was marched back to Cross Creek where he was discharged. He was in no engagement – never wounded – He served only six months as will appear by his discharge. He enlisted and never was drafted. That he has no documentary evidence but his discharge – his brother Daniel McClellan can prove his actual service, so far as his enlistment – his departure from home, and his return – That there is no clergyman near enough for him to obtain his certificate, and on account of his age and infirmity he cannot without great trouble and fatigue obtained his certificate, Said clergyman living a great distance from him –

He was born in the shire of Argyle in Scotland.

He has no record of his age.

When called into service he was living in Cumberland County – where he has ever since resided.

He was enlisted.

Besides the officers whose names he has mentioned he knew Colonel Moore, Lieutenant Johnson – Captain Davis –

His discharges herewith enclosed

This affiant further states that he lives 18 miles from the Court house and cannot get the attendance of any of his neighbors at this time, to prove his character – that the regular term of the Court of this County is not until March next. That he expected to get the testimony of persons in Fayetteville who have known him for many years, but is informed that they are not in town

He hereby relinquishes all claim for a pension or annuity except the present and declares that his name is not on the pension Roll of the agency of any State.



Daniel McClellan² maketh oath that he believes his brother Malcolm McClellan served in the War of the Revolution, and that he was marched from and returned home after a 6 months tour under Captain Rowan.

S/ Daniel McLellan
