State of North Carolina Rowan County

On this \_\_ day of November in the year of our Lord 1832 personally appeared before the Court of Pleas & Quarter Sessions for the County of Rowan it being a court of record Andrew Bostain of the County & State above mentioned aged 79 years, who being first duly sworn, according to law, doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th 1832.

That he enlisted in the Army of the United States in the year 1777 in the 2nd Troop of cavalry from North Carolina under the following officers, Martin Phifer Captain, lieutenant's name not recollected, Valentine Beard Cornet. That he marched to Charleston and was there & in the State of South Carolina part of the first 6 months, thence he was marched to the City of Philadelphia & that he remained there two or three months, that he then left the City when it was evacuated to the British, thence to [illegible, probably "Little"] York, & was sent as a guard to Boston with money to General Hancock, he then returned to Little York, & then went to Fort Pitt that he returned again to Little York and was there discharged, having served two years and a half. That he was in the battle of Germantown and a number of skirmishes. That he was in a battle against the Cherokee Indians at Middle Town under Captain Brannon, that he was in an engagement against the Tories Ninety Six under the command of Captain Brannon — He further maketh oath that he preserved his discharge & other papers which he gave to Abraham Rencker 2 percent to the War Department & which from a letter received from said Rencher he learns have been presented and are filed in the war office.

He hereby relinquishes every claim whatever to a pension or annuity except the present & he declares that his name is not on the pension roll of the agency of any State.





I John Scott of the County of Rowan & State of North Carolina do hereby certify that Andrew Bostain's discharge was in my hand in the year 1727 or 28 that they were presented to the war Department by me by letter and they were returned from that Department on account that Mr. Bostain was possessed of property sufficient for a sustenance, the contents of that discharge were as follows to the best of my recollection (to wit) that he had served 2 1/2 years in the Dragoons commanded by Captain Martin Phifer which was certified & signed by said Martin Phifer, and

that on the back of said discharge was written a passport from Yorktown to North Carolina and signed by Nourse.

[John Locke and Michael Albright gave the standard supporting affidavit.]

[facts in file: veteran died January 16, 1837; there is no family data in this file.]

[Veteran was pensioned at the rate of \$100 per annum commencing March 4th, 1831 for 2 years service as a private in the cavalry in the North Carolina militia.]
