[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Mississippi State Lowndes County to Wit

On the 18<sup>th</sup> day of February 1833, personally appeared in Open Court before Thomas Sampson, Chief Justice and Samuel B. Morgan associate Justice of the County Court for the County and State aforesaid now sitting in the Town of Columbus, Silas McBee a resident of the United States in the County of Lowndes and State of Mississippi aged Sixty Eight years who being first duly sworn according to law doth on his Oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7<sup>th</sup> 1832: That he entered the service of the United States as a volunteer Soldier during the Month of July 1781 [sic, 1780] near Tates Ferry in the State of South Carolina under the Command of Col. Thomas Brandon and in the Company of Captain John Thompson and Lieutenant Josiah Tanner and moved South with said Regiment and Company to a Fort Called Fort Anderson and from Fort Anderson the said Regiment & Company marched to the Catawby [sic, Catawba] River where said Regiment and Company united with General Thomas Sumpter's [sic, Thomas Sumter] army and in Short time after the Regiment to which I belonged arrived at Catawby River it was attached to Genl. Williams' [sic, Col. James Williams] Brigade or Devision [sic, Division] and from thence I marched with Genl. Williams' force towards Kings Mountain and perhaps two days before the army reached Kings Mountain an union of Genl. Williams, Col. Campbell [William Campbell] and Col. Isaac Shelby forces took place and the army then moved on to Kings Mountain where the army reached on the 17<sup>th</sup> [sic, 7<sup>th</sup>] of October 1781 [sic, 1780] and the Battle<sup>1</sup> of Kings Mountain was Fought during the Battle I Fought under Genl. Williams and in the Company which I first attached myself when I volunteered. In a short time after the Battle of Kings Mountain I was discharged. I served upwards of three Months from the time I attached myself to Capt. John Thompson Company until I was discharged. I returned home to South Carolina in Spartanburg District where I had been raised from a Child one year old to which District my father emigrated from Virginia where I was born. In the early part of November 1781 [sic, 1780] that he again entered the service of the United States as a volunteer Soldier under the Command of Capt. Field Padue [sic, Field Pardue] near the Adkin [sic, Yadkin] River which Company was attached to Col. Andrew Pickings [sic, Andrew Pickens] army of volunteers and I continued in said Company and under the Command of Col. Pickings until the month of March or April 1782 at which time I was Discharged. That he has no Documentary evidence and that he knows of no

person whose Testimony he can Procure who can Testify to his service. I hereby relinquish every claim whatever to a pension or annuity except the present and declare that my name is not on the Pension Roll of the agency of any State.

[This application bears no evidence of having signed by the applicant. It is attested by R. D. Haden, Clerk of the County Court.]


