Mongomery [sic] County } Fall Term 1832

On this sixth day of September 1832 personally appeared in open Court before Joseph J Daniel Judge of the Superior Court of Law now sitting Kinchen Pennington a resident of Montgomery County in the State of North Carolina aged 72 Years who being first duly sworn according to Law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress Passed June 7th 1832 That he entered the Service of the United States under The following named Officers and served as herein stated

That he volunteered as a private soldier under Capt. James Crump in the County of Montgomery in the State of North Carolina where he then resided in the year 1779, as well as he now recollects, under whom he served five months reconnoitering in said County, he was then sixteen years of age: at the expiration of Five months from the term of his engagement with Capt Crump he was discharged and he then turned out as a volunteer under Col Drury Ledbetter under whom he marched to South Carolina near Camden in the year 1780 he at this time turned out as a militia man for three months and was in the service at the time of Gates defeat [Gen Horatio Gates, Battle of Camden, 16 Aug 1780], having with some others been detached as a Guard to take charge of some Tory prisoners and a stack of arms which they carried to Cheraw Hill and delivered over to Genl Henry W Harrington [Henry William Harrington]. He was then sent as one of the Guard to protect Roger's Mills near the Cheraw Hill which was used for the public benefit and whilst there news came of Gates's defeat. he then returned to Genl Harrington and his term of service having expired he was discharged and returned home. He remained at home a short time and went under Captain Isaac Ross to South Carolina in the year 1781, and enlisted under Col Wade Hampton for Ten months and was turned over to Col Middletons [Charles Stark Myddleton's] Regiment in Capt F Boykins [Francis Boykin's] Company in Gen'l. Sumpters [sic: Thomas Sumter's] Regiment in Capt. F Boykins Company in Gen'l. Sumpters Brigade of State Troops and was severely wounded in a skirmish with a party of British Troops on the 19th day of June 1781. at or near the Juniper Springs [in present Lexington County SC, 18 June That after his wound had got well he returned and joined the troops again at Orangeburg and from there marched to the Four holes, between Orangeburg and Charleston, where his wound broke out again and he was sent back to the Hospital at Orangeburg on recovering from his wound he was discharged by maj'r Blufort [sic: William Buford] and returned home to Montgomery County where he has continued to reside ever since after having served out the Term of Ten months. That he did not serve with any of the Continental Regiments or Companies – he saw Genls Gates & [Nathanael] Greene – and DeKalb. that the only evidence in writing which he has is on file in Columbia SoCa a Distance of about one hundred and thirty miles, but that he is able to prove his service by Phillip Sill [sic: Philip Sell, pension application W4333] who served with during his last Ten months

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the Pension Roll of the agency of any State

NOTE: On 10 Aug 1833 Kinchen Pennington swore in court that Rufus Johnson who prepared his application had withheld the pension certificate from him and claimed almost all the pension for himself.
