State of North Carolina Cabarrus County: On the 10th day of October in the year of our Lord 1832 personally appeared before me John Hall one of the Justices of the Peace for and in said County William Waller [sic] a resident of the County of Cabarrus and State aforesaid aged seventy-one years who being first duly sworn according to law doth on his oath make the following Declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th, 1832 that he was born in the State of Pennsylvania in York County in the year 1761 June 5 and that he moved from that State with his father to North Carolina Macklingurgh [sic, Mecklenburg] County and in the year 1776 in fifteenth year of his age he voluntarily took up arms in the defense of his Country and that he served a tour of two months under Colonel Davidson and Mager [sic, Major] John Fipher [sic, John Phifer] and Captain Samuel Paten [sic, Samuel Patten or Patton] in March the same year he returned home and remained there until 1780 about the first of March he was drafted to serve under Captain James Reece a tour of three months and performed the same after that he was called on to serve as a minute man under Colonel Lock [sic, Frances Locke] in Captain William Houston & two weeks which service he performed and returned home in about one month in the above mentioned year he was called on by General Sumner [Jethro Sumner] as a minute man and served two weeks; also one week as a minute man when the British came into Charlotte and in the year 1781 he was called on and served a tour of two weeks under General Davidson of North Carolina when the British crossed the Catawba River the whole service amounting to about seven months. He states that he does not recollect whether he ever got a written discharge or not if he did it is lost and that he has no Documentary evidence and that he knows of no persons [or] evidence that he can procure that can testify to his service, he hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency in any State. Sworn to and subscribed the day and year above written.
