

[Benjamin Fickle was evidently pensioned under the acts of 1818 and 1832, but his applications are not in the file.]

County of Muskingum ss.

On this 22^d day of March 1822; before me, he subscriber, a Justice of the Peace for the said county of Muskingum personally appeared Benjamin Fickle who, on his oath, declares that he is the same person who formerly belonged to the company commanded by Captain Jonathan Morris in the regiment commanded by Colonel John Gunby in the service of the United States; that his name was placed on the pension roll of the state of Maryland that he never received a certificate of that fact, under the signature and seal of the Secretary of War





To the War Department

I Benjamin Fickle of Coshocton County and State of Ohio do hereby certify upon honor That I Received a commission of a Lieutenant in the line on continental establishment, on the last of March or first of April in the year 1780, and was attached to the 7th Regiment Commanded by Col John Gunby of Frederick Town in the State of Maryland, in which I served to the end of the War in the year 1783, for further evidence I Refer you to the Rolls in the war department & to my pension certificate accompanying this Application to increase my pension to the full pay of a Lieutenant in the line; From the 11th of March 1831 under the Act of Congress of the 7th June 1832. If you should decide against this application, Return to me the enclosed certificate, though I have no doubt but you will comply with my Request With Respect &c I am yours &c.

I hereby certify that it appears on the Arrangement of the Maryland Line in this Office that Benjamin Fickle was a Lieutenant in the said Line in the service of the United States, that his Commission bere date on the 19th of February 1780, and that he continued in said service until the conclusion of the War. Be it remembered, that on this 15th day of August 1857, before the undersigned Probate Judge in and for said County, personally appeared Isaac H Fickle, who being duly sworn according to law, on oath declares:

That he is one of the remaining children of Benjamin Fickle, deceased, who was a Lieutenant in

the Maryland line, on Continental Establishment, during the war of the Revolution. That the said Benjamin Fickle was wounded in the service in said war, and was an invalid pensioner at the time of his death, at the rate of \$17 per month. Also, that he was a pensioner under the act of 7th June 1832, at the rate of \$320 per annum, but that he never drew any pension under the act of 15th May 1828, to the benefit of which it is claimed that he was entitled.

This declarant further represents, that the said Benjamin Fickle died on the 20th day of May 1839, leaving a widow, Phebe Fickle, who is since dead. That the said Benjamin Fickle also left Eight children of whom the following named still remain, and are the only surviving children of the said Benjamin Fickle deceased, viz. Rachel Vansky Catharine Kill Patrick and this affiant Isaac H Fickle

And this declarant now claims, on behalf of said surviving children, any arrears of Pension that may be due under said act of 15th May 1828, or any other act, and hereby appoints J. T. Combs of Washington City his Attorney to prosecute said claim
