[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Know all Men by these Presents, That I John Chambers of Bullocks Creek in the County of York, for divers good Causes and [illegible word] made unto me moving [?], I have made, ordained, constituted, appointed my trusty Friend Mr. Andrew Love my true [paper damaged text missing] Attorney, for me, and in my Name, to ask, demand, and receive of and from the Publick Treasury in the City of [paper damaged and text missing] [illegible word] coming to me from thence for Indents, Giving [paper damaged and text missing] granting to my said Attorney, my sole and [paper damaged and text missing] Authority, to take, pursue and follow such legal Courses [paper damaged and text missing]covery receiving and obtaining of the same, as I myself could do, were I personally present, and upon the Receipt of same, Acquittances or other sufficient Discharge is for me, & in my Name to make, sign and Deliver. In witness whereof, I have hereunto set my Hand and Seal this 16th day of September in the year of our Lord 1780
