[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 2: Printed form of Indent no. 276 Book M dated October 1, 1784 “delivered to Mr. Mainyard Colley [sic] late Private in Barnett’s [Jacob Barnett’s] Troop H Hampton’s [Henry Hampton’s] Regiment Sumpter’s [Thomas Sumter’s] Brigade this our Indented Certificate for the Sum of Ninety-four pounds Sterling being amount of pay and bounty due him for services in that troop together with Interest thereon from the first of April 1782 to the date hereof Agreeable to an Act of General Assembly of the Eleventh of March last....]



Received [illegible] November 1793 from General Thomas Sumter one Indent issued to Maynard Colley [sic] for eighty-six pounds 10/8 with all the interest due thereon, the same being attached² in his hand as Garnishee of the said Colley.

[p 5: Printed form of Indent No. 33 Book A dated June 12, 1792 “delivered to Mr. Mainard Colly [sic] this Indented Certificate, for the Sum of Seventy-one Pounds Ten Shillings & Six Pence Sterling being the Amount of Pay Balance of Bounty and Extra allowance for his Services in Colonel Wade Hampton’s Regiment of Cavalry.”]
