[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]



Charles Crowley entered into the service, August 1776 [text too faint to discern] commission as a first Lieutenant in the Navy of the State of South Carolina 19th of April 1778 his Captain's Commission 10th October 1780 he continued regularly in the service from his first entering into it to the Enemy [text too faint to discern] during which space of time he was a prisoner [text too faint to discern] he be put on a footing with respect to his receiving Commutation those Offices of Commodore Gillon [Alexander Gillon] who went with him to Europe

I do hereby Certify that Captain George Larigut [?]² was an Officer in the Navy of this State for at least twelve months before the Surrender of Charleston [Charleston South Carolina fell to the British on May 12, 1780] and that he was sent a prisoner to the northward at the same time as I was sent there he petitions as above


