[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The State of South Carolina to Captain Hennery Anderson Dr. £912.10.0

I do hereby certify that Henery Anderson Did Bear a Captain's Commission and Commanded a Militia Company in my Regiment from the 1st Day of January 1783² until the last of October following During which time he acted on horseback and Discharged the Duty of a good officer for which he is justly entitled to pay but he the said Captain Henry Anderson being Murdered by the Tory Party the last of October 1783 was Neglected to have been Returned in any pay Bill: his widow made application to me to see her righted in this case.

I do therefore certify that the above Duty was faithfully done by the above said Anderson September the 23rd [1783]

I do Certify the above Duty was Performed as I was in the service of my country at the same time.
