[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 2: Printed form of Indent No. 168 Book M dated October 1st, 1784 “delivered to Mr. David Hayes late Sergeant, Alexander’s [William Alexander’s] Troop, W Hampton’s [Wade Hampton’s] Regiment Sumpter’s [Thomas Sumter’s] Brigade this our Indented Certificate for the Sum of one hundred and five pounds fifteen Shillings Sterling being amount pay and bounty due him for Services in that Troop Together with Interest thereon from the first April 1782 to date hereof Agreeable to Resolution of General Assembly of the 8th March last.”]


[p 3: Reverse of the above Indent bearing the following endorsement, among others:

[p 4: Printed form of indent No. 2028 Book X dated 10th January 1787 “delivered to Mr. David Hayes this our Indented Certificate for the Sum of Twenty-two pounds thirteen Shillings and four pence Sterling for arrears of Cloathing due to him for Services in Sumter’s Brigade and for Special Bounty of a horse to which he was entitled per Certificate of the Commissioners for adjusting the Claims against that Brigade.”]

[p 5: Reverse of the above Indent bearing several endorsements for receipt of annual interest due on the Indent, but none of the endorsements are by the veteran.]




[p 7: Very poor image of a document which is dated November 23rd, 1781 which appears to be
