[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 2: Note: The entire upper portion of this document is so faint as to render it illegible. Most of the bottom portion of the document can be read and reads, as I decipher it, as follows:

... The said Negro to any person what [illegible text] to Samuel Maxwell (and the said Negro is the one that he the said Samuel Hogshead is entitled to for his own Personal Service in the State Troops of South Carolina) who have purchased the said Negro and paid the full sum of one hundred pounds in gold and silver (dollars at 18 Shillings) this Receipt shall [illegible text] to the public of South Carolina – further the said Deponent Saith upon his oath that he never [text too faint to discern] to his own use public horses saddles bridles arms or ammunition or conveyed them away but what he made use of in the public Service and further Saith not.
Sworn before me this 30th day of June 1782

[p 3: Printed form of Indent No. 2125 Book X dated January 21st, 1778 “delivered to Mr. Samuel Hogshead this our Indented Certificate, for the Sum of Twenty-five pounds five Shillings and ten pence Sterling (Special Bounty) and arrears of Cloathing Service of Sumter’s [Thomas Sumter’s] Brigade per Certificate from the Commissioners for Adjusting claims of said Brigade.”]

[p 4: Reverse of the above Indent bearing the following endorsement, among others:

I do hereby certify that as Attorney for Samuel Hogshead I have transferred to Doctor Isaac Alexander the whole Right, Title and Claim to the within Indent.
