[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina Rutherford County } Stephen White Personally Appeared before me one of the Justices of said County and being Duly Sworn on the Holy Evangelist of Almighty God Deposeth and Saith that During the Time of the Late war he never Plundered nor took any thing belonging to the State of South Carolina or Any of the United States nor Any Individuals thereof more than what he was Commanded by his officers such as provisions and forage &c Necessary to Carry On the war Nor Never Converted to his own Use Directly nor Indirectly any Utensils found by the State more or less but Returned all to his Commanding officers Except wearing Clothes. Sworn before Me this 14th Day of November 1783


[p 5: This image is totally illegible except for the possibility of being dated July 1785]

[p 6: Printed image of Indent No. 310 Book N dated April 4th, 1785 [could be 1784] “delivered to Mr. Stephen White this our Indented Certificate in the Sum of Ten Pounds Seven Shillings and one pence half penny for 91 Days Militia Duty in 1780 as per Account Audited.”]

[p 7: Reverse of the above Indent bearing endorsements by John White, Senior for 2 years interest on the indent and another endorsement by John White as executor of Stephen White. The letter endorsement appears to be an assignment of the Indent to Christopher Williman.

Know all men by these presents that I Stephen White of the County of Rutherford and State of North Carolina have Bargained and Sold unto Jacob Finzant [sic] of the County and State aforesaid, for the Consideration of the Sum of thirty-nine pounds, my Right and title of a Negro Draw Due to me for Services Done in the State of South Carolina in Captain Waters' [Philemon Waters'] Company in Colonel Middleton's [Charles S Myddelton's] Regiment under the Command of General Sumpter [Thomas Sumter] and I Do warrant and Defend said wages or Draw from any persons laying any Just Claim thereon to in witness whereof I have hereunto Set my hand and seal this 11th day of April 1785
