
[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

[Note: The images of all of the documents in this file are very poor. Some of what follows is my conjecture of what the documents show based on having seen numerous examples of similar documents in the South Carolina Audited Accounts.]

[I hereby] Sell all my Right and Title to the Chance I have of a Negro due from the State of South Carolina and everything for [text too faint to discern] this Service to James Clarke and do [undeciphered word] Authorize him to receive said Negro. In witness whereof my hand the 15<sup>th</sup> Day January 1781

[p 4 : Printed form of Indent No. 326 Book kept book M dated first of October 1784 “delivered to Mr. Francis Congoler late Private in Mills [John Mills’] Troop, H. Hampton’s [Lt. Col. Henry Hampton’s] Regiment Sumpter’s [Thomas Sumter’s] Brigade this our Indented Certificate for the Sum of Ninety-four pounds Sterling being amount pay and bounty due him for Services in that Troop Together with Interest thereon from the first April 1782 to date hereof Agreeable to Resolution of General Assembly of the Eleventh March last.”]

[p 5: Reverse of the above Indent bearing endorsements by Peter Bocquet, Commissioner of the South Carolina Treasury, Thomas Sumter Junior and John Boykin. How these men acquired an interest in the Indent is not disclosed by the documents in this file.]
