[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina Burke County

This Day came Daniel Killian [sic] before me one of the Justices of said County and made oath that the State of South Carolina was Justly indebted to him one lightly [likely] gron [grown] Negro and that he served his time truly and faithfully in Colonel Midletun's [Charles S Myddelton's] Regiment as a light Dragun [light dragoons] under the command of General Sumter [Thomas Sumter] and that he did not plunder nor take any of the property of South Carolina to his own use and he hath not received no satisfaction for the said Negro and that he never bargained sold nor made over the said Negro to any person Sworn before me this 5 day of September 1783

This is to certify that I have bargained sold and delivered un [unto] John Sumter the Negro that is due me for my ten months service in the State of South Carolina as a light Dragoon in Colonel midletons ridgment under the command of General Sumter and all the bounty that I was entitled to for my 10 months service and that I know myself fully and dearly [?] Satisfied for the same as witness my hand this 5 of September 1783
