[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Mecklenburg County} This Day personally Appeared before me Seth Rodgers a Soldier in Colonel William Polk's Regiment and Captain Thomas Shelvey [sic, Thomas Shelby's]² Company And made Oath as the Law Directs that by his Service in the State Troops of South Carolina Commanded by General Sumter [Thomas Sumter] and that he the said Seth Rodgers is Justly Entitled to one Negro Agreeable to the Terms of the Enlistment made by the said General and that the said Seth Rodgers Did Not Violate his said title Nor sell nor Dispose of the said Negro to any person What So Ever but to James Maxfield [probably James Maxwell] and that the said Negro is the one that he the said Seth Rodgers is Entitled to for his own personal Service in the State Troops of South Carolina has purchased the said Negro and paid the full sum of sixty pounds this Receipt shall be good to the public of South Carolina and no other and further the said Deponent Saith upon his oath that he never converted to his own use public horses, saddles, Bridles, arms or ammunition or conveyed them away But what he made use of in the public Service and further saith not

I Seth Rogers [sic] do assign over all my Right of all my Cloathing Due to me from the State of South Carolina for my ten months Service unto James Maxwell this 17 of July 1786.

² Captain Thomas Shelby recruited men to join the South Carolina State troops under Brigadier General Thomas Sumter for 10 months service in the Light Dragoons. The man he recruited, however, ended up under the command of Nathaniel Marshall Martin in William Polk's Regiment under Sumter.

Seth Rodgers appeared before me one of ^{the} justices for Mecklenburg County and made oath as the law directs that he never received any Part of the above Cloathing only one pair of Cloth britches.
