[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable Senate and House of Representatives of the State of South Carolina Your Petitioner Humbly Sheweth that he were a Soldier in the Revolutionary war in the Militia on the Liberty Side Commencing under Captain William Miles of Spartanburg District of this State in Colonel Thomas's [John Thomas, Sr.'s] Regiment Shortly after the Commencement of the War and continued with him a considerable time on duty he left a part of us to Guard Princes' Fort and he took a part of the Company and went in pursuit of a Parcel of out Lying Tories in which he got Killed, then Mason Folia [sic, Mason Foley] took the Command and appointed me orderly Sergeant I Continued with him until after the British Took Charleston [Charleston South Carolina fell to the British on May 12, 1780] then from Folia_mes Company Filed to North Carolina and Virginia as Refugees I stopped in North Carolina Orange County shortly after I arrived there I attached myself to Captain Abraham Allen's Company and were with him in Several Routes after the Tories and were then Drafted for an eighteen month Tour but peace were made before the day of Rendezvous and we dismissed, –

The following is a Schedule of the Property I now possess Viz. myself old and infirm not able to Labor and my Wife nearly as infirm as myself a small Tract of Land and old Negro Man quite infirm and an old Negro Woman who is & has been much afflicted with a Small Stock and some Household Stuff & Furniture. And your Petitioner Humbly Prayeth that your Honorable Body will take my Case into Consideration and allow me what you in your Judgments may think I Merit & your Petitioner will ever Pray



I do hereby Certify that I were well acquainted with Ruben Dollar before and During the Revolutionary War he Boarded in the same House with me all the time of the War except while he were in the Service of his Country on the Liberty Side I were knowing of his Services under the command of Captain William Miles in Colonel Thomas's Regiment and were knowing to Mason Fror [sic] taking the Command after Captain Miles got Killed by the Tories were knowing of his Company fleeing from the State for Safety and went with this Deponent Reuben Dollar to Orange County North Carolina and were knowing of his going and attaching himself to Captain Abraham Allen's Company and were several Tours after the Tories were knowing to his being Drafted for an Eighteen month Tour but Peace being made before the day of Rendezvous they were all Dismissed, Given under my hand this 19th of November 1831

Finding it Necessary to Value the Property owned by an applicant I give the following Schedule viz. one Hundred and Fifty acres Land Estimated at Four Hundred & fifty Dollars one old Negro man not thought [worth] more than to support himself one old Negro Woman Estimated at Fifty Dollars one Mare Colt Estimated at Sixty Dollars Two Cows and Calves & two yearlings Estimated at Twenty Four Dollars Nine Sheep Estimated at Nine Dollars nine Shoats Estimated at nine Dollars Two Beds & Furniture Estimated at thirty Dollars other Household Stuff Estimated at Fifteen Dollars making in all Six Hundred and Forty Seven Dollars


