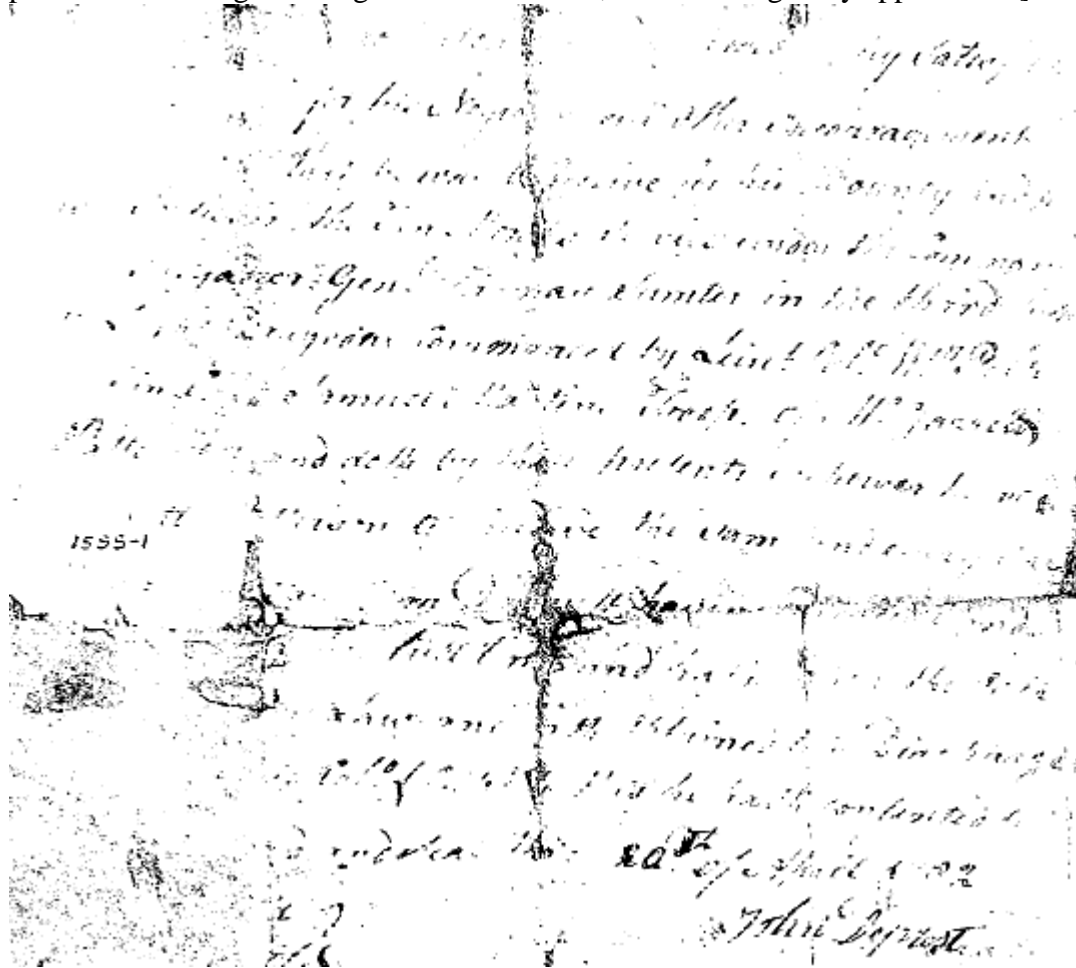

The image of the document even though retaken is still so faint as to be largely illegible but I am reasonably comfortable that I have properly identified the unit in which the claimant served. If anyone can provide a more legible image of the document, it would be greatly appreciated.]

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]


State of North Carolina

I Samuel Martin who formerly served in the service of the state of South Carolina a Captain in the third Regiment of Light Dragoons during the space of ten months in General Sumters [Thomas Sumter's] Brigade Do Certify that John Dupriest and John Taylor served their full time in my Troop and is intitled to all the privileges and pay² that any of the Soldiers in that Brigade were Intitled to and as such were Returned on my Pay Bill to the Commissioners for Settling that Brigade's Accounts and that I believe they the said John Taylor & John Dupriest hath not disposed of their pay to any person before or after they sold to Janat Patterson.

Given under my Hand at Charlotte this 20th Day of September 1784

S/ Saml. Martin [Samuel Martin]

S/ Wm Polk [William Polk] Lt. Colo. Comdt

² Men who agreed to serve in the 10 Months State Troops of South Carolina from March 1781 until February 1782 were promised payment in the form of Negro slaves confiscated from the Tories. Such horrific pay was referred to as "Sumter's Wages."
