
[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

[p 2: Printed form of Indent No. 137 Book O dated March 31<sup>st</sup>, 1785 "delivered to Mr. Richard Duggan this our Indented Certificate for the Sum of Eight pounds Eleven Shillings and five pence Sterling for Sixty days militia duty done in Colonel Winn's [Richard Winn's] Regiment of horse in 1782 as per Account Audited &c &c"]

[p 3: Reverse of the above Indent bearing endorsements by Colonel Richard Winn, including the following:

I Richard Winn of Winsboro [sic] Esquire do hereby assign the full amount of principal & interest now due [illegibly faint text] on the within Certificate & which I have purchased of the within named Richard Duggan, as appears by his order<sup>2</sup> now lying in the Office of the Commissioners of the Treasury (unto Messrs Hawson [? Very faint] Price & Co. of Charleston Merchants there Executors, administrators & assigns for value [text too faint to discern] this twenty-fifth day of July 1785
