[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]





If my Publick accounts has passed into an indent pray Let the Barrer Mr. Hugh Means have it and in so doing you will oblige your Humble Servant

A handwritten signature in cursive script that reads "James Park". The signature is written in black ink and is positioned below the printed name "S/ James Park".

[Note: The file contains five receipts, the first dated June 27, 1828 in the amount of \$120 payable on account of "James Parks Annuity" and the last dated June 7, 1834 in the amount of \$60 for the annuity due "James Parks" up to March 1834. Each of the receipts except for the first one is signed by James Beaty. The first receipt is signed by James Catheart for James Beaty. These receipts indicate that James Park was placed on the South Carolina pension list at the rate of \$60 per annum commencing in 1827. Unfortunately, neither this file nor the South Carolina Archive's online documents contain the petition on which the veteran was granted a pension. Likewise, the documents in this file do not indicate the basis on which James Beaty acted as the person who actually received the pension for James Park.]
