[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

The Committee to whom was referred the Petition of Elizabeth Warnock Widow Report –

That they have examined the allegations therein set forth, & find them to be true, therefore they are of Opinion that she ought to be allowed the Annuity due to Widows by the Resolutions, or Laws of this State since the year 1780, as She has never received any part of the Annuities allowed by Law as aforesaid, & as she is in a most distressing & helpless Situation, with two Children, too young to be bound to any trade or handicraft, in which manner she has disposed of three of her Children, and two others being Daughters live with a friend & work for their living, your Committee also, are of Opinion, that the Treasurer should be authorized (by a Law brought in for that purpose) to give an order in behalf of the State for the amount of the said Annuities due by Law since the year 1780 as aforesaid that the same may be discountable out of any duties which may be due & payable into the Treasury of this State –

State of South Carolina Charleston District

Major Amos Windham of Cheraw District, being duly sworn maketh Oath. That to his own knowledge, Charles Warnock (a private militia man in Captain John Nelson's company General Marion's Brigade) was killed near Camden in the year 1780 by the British Troops

To the Honorable John Ward President & the Honorable Members of the Senate.

The petition of Elizabeth Warnock

Humbly Sheweth that your petitioner's Husband was killed in the last War in the Service of his country; under the command of General Marion [Francis Marion] "That your petitioner was left with a numerous and small family of Children – and that a considerable part of her property was taken & destroyed by the Enemy, and that she never received any compensation for the Services done by her husband in the War, nor has never received any part of the Pensions that was Granted previous the year 1786 owing to her inability to make Application in due time – what property was left is now entirely expended – Your petitioner lost the use of her Lambs by the Rheumatic pains so that she cannot rise up out of Bed nor lie down without help, & cannot even feed herself" Eighteen years have passed since she was seized with the above complaint – That the pension Granted for the relief of Widows is inadequate for her Support. – Your petitioner being reduced to Want is induced to Apply to the Generosity of your Honorable body humbly praying that you will take her case into a Serious consideration & Grant such further relief as you in your wisdom shall Judge proper – Your petitioner in duty bound will ever pray. –
