[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]


14 April 1784 – I have this Day received from General Richard Winn, the full value of my Account against the Public, now lying in the Auditor's Office, for auditing, and afterwards to get an Indent for the same, from the Treasury, and I do request the Commissioners of the Treasury of the State of South Carolina to make out the Indent for the same, with the Interest pursuant to the resolve of the Legislative in that Case, to him the said Richard Winn, and to accept this as a Receipt in full against the public, for the Said Account

[p 5: Restatement of the veteran's services as set forth above but in a slightly different format.]

[Note: Beginning on page 6, there are documents relating to a pension granted to Thomas Hays by the State of South Carolina for his service in the revolution. Whether or not this is the same Thomas Hays as referred to above, I cannot discern from the documents in the file because the petition itself is not included among the documents. The documents that are included in the file indicate that a veteran by the name of Thomas Hays was granted an annuity of \$60 per annum with the 1<sup>st</sup> receipt being dated May 25, 1825. There is a document dated December 11, 1839 indicating that the veteran, then living in Anderson District South Carolina was still alive and was to receive a payment of \$60 on March 1, 1840.]

We hello hello: sweetie Sally I thought she was right he holds a sweetie full phone calls for you may be spam the Undersigned Petitioners humbly Sheweth that whereas Mr. Thomas Hays (the Well digger) a State Pensioner departed this life last December and his pension order for Sixty Dollars was issued by the Treasurer to the Tax Collector but he (the Tax Collector) thought it was not his duty to pay the order and did not pay it.

Now we your Petitioner's humbly pray if that your Honorable body will take the case into Consideration and allow Mrs. Margaret Hays (the old surviving widow of the said deceased Thomas Hays) who was his wife in the time of the revolution) the Sixty Dollars Pension which was due at the time of his death and she the said Mrs. Hays is in quite indigent circumstances and not able to get along without assistance and shall suffer unless you grant her the said pension and place her on the pension roll which we humbly hope you will do and your petitioners will ever pray this November 7<sup>th</sup> 1840
