[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable Senate and House of Representatives of the State of South Carolina
The petition of Ann Hodge widow of Thomas Hodge humbly Sheweth that her Husband was a Militia Soldier in the Revolutionary War and Served his Country faithfully as a Militia Soldier almost the whole of the war at every call and was in the floriday expedition [Florida Expedition], at Gates defeat [Battle of Camden, August 15-16, 1780] at or near Camden and the Congaree near Granby under Colonel Taylor [Thomas Taylor] while the British forces was infested in Granby and served each Subsequent Call until the end of said War. My property is my own Cloathing and a small Bed and I pray your relief

Personally appeared before me Jonathan Watts one of the Justices in and for the District aforesaid Ann Hodge and made oath that the above Statement is Just and true

Sworn to this [obliterated] day of December A.D. 1835

Personally appeared before me Jeremiah Taylor² and made oath that him self Served a three months tower [tour] at the fore holes bridg [Four Holes Bridge] under Captain Murphey with Thomas Hodge in Col. Robert Goodwyn on [sic] a Regiment of South Carolina Militia Sworn to this 7th day of December A.D. 1835

South Carolina Fairfield District} Personally appeared before me Jonathan Watts one of the Justices of the peace in and for the District aforesaid Benjamin Hodge and made oath in confirmation to the foregoing oaths above stated that he was well acquainted with the above mentioned Thomas Hodge & Ann Hodge his wife before mentioned that they lived together & always passed as man and wife previous to the Revolutionary War & during said services rendered by said Thomas Hodge and ever since until the death of the said Thomas Hodge which the said deponent has no doubt but what they was legally Married previous to said War. The deponent further saith that he has a Stite [sic] recollection of said Thomas and Ann Hodge his wife being Married.
