
[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Personally appeared Saml Hogshead [Samuel Hogshead]² before me the subscriber and made Oath that William Hogshead his Brother enlisted as a [text too faint to discern, partial word "mo...", could be 'mounted'] Soldier under the Command of Genl Sumter [Thomas Sumter] that he served as a Serjeant in the Same until his Death which was in the Service that he is entitled to the pay allowed the Soldiers that Neither he nor I who am Heir, have rec'd any pay for the Same my Rights whereof as to the full Chance I have Sold for Value rec'd by the Hands of David Allison, to Genl Thos Polk [Thomas Polk]. Sworn to this 13th day of October 1784
Before S/ J. M. Alexander S/ Samel Hogsd



14th Octr. 1784 Rec'd of Genl Polk the Sum of fifty pounds in full for the above
