[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Dear Sir

I have [text obliterated] Mr. [undeciphered name] Fendly [?] to apply to you to Draw a Petition to the Legislature in favor of ___ Carroll who is Daughter to Mary Jones who drew an annuity of Sixty Dollars per year in Consequence of her Husband Bartley Jones having been killed in the War of the Revolution, I may well know it when I assisted to Bury him. She the said Mary Jones died about a year ago having Drawn her Annuity up to March 1821, her

Daughter ___ Carroll is very Poor & had the trouble of the Annuitant in her last Sickness; thereby her Daughter ought to have the Six Months annuity or what all to come to the old [text obliterated] from March 1821 till the time of her Death in October 1821 to enable her to get it. I hope you will draw a Petition in her favor and Present it – you [undeciphered word] give Mr. Fendly all the Directions Necessary, I have [undeciphered word or words] day right.

To the Honorable Speaker and other Members of House of Representatives –

The petition of Kisiah Carrel Heirs of Mrs. Mary Jones widow of Bartley Jones Sheweth this Honorable body that the said Bartley Jones for services during the Revolutionary war Received a pension of Sixty Dollars per annum which was continued to his widow after his Death, that the said widow has lately also deceased having at the time of her Death due and owing the Sum of Thirty one Dollars or thirty two Dollars part of the said pension, which she disposed of to your Petitioners that your Petitioners have applied for the Said Amount to the proper officer he Refused to pay without the Sanction of your Honorable body. Your petitioners therefore pray that you will take her case into consideration and make such order as to your Honorable body may seem Meet,² and your Petitioner in duty Bound will ever pray.

Report of the Committee of Pensions on the Petition of Kesiah & Patsy Carroll,

² In Samuel Johnson's Dictionary of 1755, the first definition of the word "meet" he gives is "Fit; proper...." Johnson noted that even at that time the word "meet" was rarely so used. It must have become fairly popular in South Carolina in the early 1800's, however, as it appears in many petitions submitted to the SC Legislature.

Your Committee Respectfully Report that it has under consideration the Petitioners' Case, and find that Mary Jones Deceased was on the Pension List at the time of her Death, and that from her Last payment to the time she deceased is Seven months, therefore recommend the following Resolved that the Treasurer of the Upper Division pay to the said Patsy and Kesiah Carrol the amount Due for the above period of Seven Months, or to either of them, on proof to the Treasurer that they or either of them are Illegally Authorized to receive the same
