[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]



The State of South Carolina

To the Honorable the Speaker and members of the Senate of South Carolina

The humble petition of Jacob Killingsworth, a resident of Richland District, Sheweth to your honorable body, that during the time of his service as a public Soldier in the defense and protection of his country at Charleston, in the last winter and spring, the only Negro fellow of your petitioner named Frank was taken, tried and sentenced to be hung for burning a barn of Mr. David Powell and that on the 24<sup>th</sup> of February last, was executed publicly according to his sentence, whilst your petitioner as a public soldier, was engaged in the defense and protection of Charleston and its vicinity.

Your petitioner feelingly states to your honorable body, that he is poor, infirm and weak in body and on him alone depends a large, young and helpless family, for their support, maintenance and education.

Your petitioner again states to your Honorable body, that Frank was the only Negro he possessed to aid him in the support of his young and numerous family.

In tender consideration of the premises, your petitioner prays your honorable body to take his lost into your consideration, and that you may be pleased to allow and order him a compensation in money, equal in value to this Negro Frank and thus to relieve him from his loss and to aid him in the support of his young and rising family, And your petitioner as in duty bound will ever pray &c

[there is no indication that the petitioner executed the petition]

This is to Certify that the within named Negro Frank was brought before me for burning or setting fire to a barn, the property of David Powel [sic] and sent [sic, sentence?] was brought against him agreeable to the act of the law and he was found guilty and condemned to be hanged on the 24<sup>th</sup> day of February 1815, on which day his body was executed.
