Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable John Julius Pringle Esquire Speaker and the other Honorable Members of the House of Representatives

The petition of John Carne late Apothecary in the Continental hospital of this State – humbly Sheweth –

That your Petitioner at the Commencement of the War impressed with a Zeal for the American cause, entered the hospital Department in this State, and continued in Service to the peace, during this time your Petitioner, was for fourteen Months a prisoner in this City, and experienced the Severest duty, and although a prisoner, he was at all times ready to assist his distressed Brethren, this every Gentleman in the Hospital Department will verify – After the General Exchange of Prisoners your petitioner was sent to Virginia, where he was led to believe provision was made to compensate his past misfortunes, but in this was disappointed from the Necessity of the times. Your Petitioner continued doing his duty as a faithful Officer until the hospital in Virginia was dissolved - then by order of General Washington repaired to Philadelphia to take orders from the Director General of Southern hospitals. Your petitioner on his arrival in Philadelphia, was Ordered to South Carolina, and with Medicines & other hospital Stores without the Common necessaries of Life, or even a horse to lighten his Journey in his advanced age of Life during the Severity of Winter – Yet amidst all his misfortunes, hardships and a large family, whom by his strict Adherence to the American Cause often wanted Bread and other necessaries to Support Nature and does in this present moment Suffer in a like manner, he had hopes of Relief from the State

he particularly belonged –. Your Petitioner therefore humbly prays Your Honorable house will take his Case in Consideration and Grant him the Commutation already granted to every other Gentleman in the hospital Department and your Petitioner as in duty bound will ever pray.
