

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 2: Printed form of Indent No. Book Y dated August 22nd, 1785 issued to "Mr. Dennis Brown this our Indented Certificate, for the Sum of Seventy-nine Pounds, one Shilling & five pence three farthings, Sterling for Pay due him as a Mattross [matross]² in the South Carolina Continental Regiment of Artillery in 1780, 1781, 1782 & 1783 as per Account audited, on which no Interest is to be allowed until a Year's Interest becomes due...."]

[p 3: the reverse of the Indent. It contains three endorsements acknowledging annual interest payments all signed by Samuel Beckman. What right Beckman had in the indent is not shown in the documents in this file.

² A matross was a soldier of artillery whose duty was to assist the gunner in loading, firing and sponging the artillery piece. Matrosses were ranked as privates.
