[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina, Chester District

On this 24th day of October personally appeared in open court before William D. Martin Judge of the court of Genl Sessions & Common Pleas now sitting Samuel McElhaney a resident of Chester District in the state aforesaid aged about 64 years who being first duly sworn according to Law, doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th, 1832.

That he entered the service of the United States under the following named officers and served as herein stated.

I was drafted into service about the close of year 1777 according to my best knowledge in Captain Philip Walker's company & Col. John Winn's Regiment in Chester District South Carolina, and marched from thence to Charleston. Thence to Purysburg near the mouth of the Savannah River where at the end of three months from the time of my draft I was discharged & returned Home—whence not long afterwards I was again called by a second Draft & marched under Captain Philip Walker & Col. Edward Lacy [sic, Edward Lacey to the Black Swamp where I was placed under Col. Simmons. Thence to Dorchester on our way we had a skirmish with the enemy. At Dorchester I was discharge & again Returned Home, the enemy having taken to their ships & made their escape. I next volunteered under Capt. John Mills & Col. Lacey & Genl. Thos. Sumter [Thomas Sumter] & marched to Headquarters at Clem's Branch in the vicinity of Charlotte North Carolina. Thence to Kings Mountain & fought in the famous Battle [October 7, 1780] which took place there with the British under Genl. Firguson [sic, Patrick Ferguson] under the command of Col. Williams [James Williams]. Thence to Col Walker's up the Broad River guarding & nursing those who were wounded in the fight & thence we returned home—After which I was frequently out on various Scouting & Patrol Parties—I have no Documentary Evidence of my Services—know of but one man now living who can testify as to my services—Steven McElhanev.

To the interrogatories propounded to me by the court I answer—

- 1st. I was Born in Lunenburg [County] State of Virginia
- 2nd I have no record of my age. It was burned up in my father's Bible.
- 3rd I was twice Drafted & volunteered once.
- 4^{th} I was living in Chester Dist. S. Carolina when called out & now live in York the adjoining District.

- $5^{\rm th}$ I Remember Genl. Lincoln [Benjamin Lincoln] and his command at the Black Swamp.
 - 6. I never received a written Discharge.
- 7. I Refer to Steven McElhaney to Testify as to my Revolutionary services & to the Rev'd Robt. Walker & William Stringfellow who can testify as to my credibility & good character & also touching their belief to my services as a Revolutionary Soldier.

I do hereby relinquish every claim whatever to a pension or annuity except the present and declare that my name is not on the Pension Roll of the Agency of any State only that of South Carolina.

State of South Carolina Chester District: Personally appeared before me Peter Wylie Judge of the court of ordinary of said District in open court Samuel McElhenney who being duly sworn saith upon oath that by reason of old age & consequent loss of memory he cannot swear positively as to the precise length of his service but to the best of his recollection he served not less than the periods mentioned below viz. the first tour in 1777 when in Capt. Walker's Company, Col. Winn's Regiment served not less than 3 months. Second Tour in he thinks in the year 1779 Drafted again when he marched under Capt. Philip Walker's Company Col. Edward Lacey's Regiment to Black Swamp where placed under Col. Simmons served not less than 3 months. Third Tour volunteered under Capt. John Mills Col. Lacey's Regiment under General Sumter marched to the headquarters Clems Branch and at the time when he was at them Battle of Kings Mountain served not less than 9 months this last tour was in the year 1780 & 1781. This service was exclusive of a great deal of scouting & for which service he claims a pension this deponent further saith that the person who wrote his declaration must have made a mistake in saying he was put 64 years of age as he was 16 years of age when he Entered service in the latter part of 1777 & is of opinion he told the writer who wrote his declaration so which would have made him above 70 years of age.

named & says that he this deponent was in the service with the declarant in his two last tours and has reason to believe the other facts stated in said Amendment is correct both with respect to his service and age as he this deponent is a brother of the declarant.

Thirty Three Dollars – he states that all his proof & certificates as to his being a Revolutionary soldier are filed in the Treasurers office – Your petitioner prays that he may be Entered as a State pensioner or that he may be allowed the difference between his State pension & the pension he draws from genl. govt. with the arrearages – Your petitioner states that he is extremely destitute [undeciphered word or words]
