[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Illinois, Marion County

On this 10th day of November 1843 before the Probate Justice of the peace in and for the County aforesaid personally appeared Sally Barbee a resident of said County of Marion aged Seventy-five years who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed on the 7th of July 1838 entitled an act granting half pay and pensions to Certain Widows.

That she is the Widow of Joseph Barbee who served three terms of duty in North Carolina in the Revolutionary War as a light horseman in the service of the United States, each tour consisting of three months, making nine months actual service for two of the tours so performed she has his discharges now here present which are here exhibited the benefit of the other tour (with the discharge) he sold to a Edward Trice.

She further declares that she was married to the said Joseph Barbee on the 1st day of October 1782 and that her husband the aforesaid Joseph Barbee died on the 5th day of October A. D. 1826. She was not married to him prior to his leaving the service but the marriage took place previous to the first day of January 1794 (viz.) at the time above stated. That she has a Bible here present which contains the record of her marriage and the births of her children which is in the handwriting of her husband the said Joseph Barbee and that she has remained a Widow ever since his death. Sworn to and subscribed the day and year above written before me.

In his affidavit he describes himself as being the son-in-law of Sally Barbee, the widow of Joseph Barbee who he understood to have been a revolutionary war soldier who died October 3, 1826. The affiant also attest to the authenticity of the Bible record exhibited in support of the widow's claim.
