Pension application of Abraham Lieuzadder (Lienzader) W24554 Leah Lieuzadder f68VA

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]


On this 23rd day of June in the year of our Lord 1846 personally appeared before me Zadoc Davis one of the Associate Judges of the Court of Common Pleas within and for the said County of Guernsey Leah Lienzader [Lieuzadder] a resident of the Township of Center in said County of Guernsey age seventy-nine years who being first duly sworn according to law doth on her oath make the following Declaration in order to obtain the benefits of the provisions made by the act of Congress passed July 7, 1838 entitled "An act granting half pay and pensions to certain widows:" That she is the widow of Abraham Lienzader who was a Private in the Army of the Revolution, that she is not able to name the company or Regiment in which her said husband served but that he resided at the time he entered the service within the present bounds of Green County in the State of Pennsylvania, that the said Abraham Lienzader volunteered in a company commanded by Captain Herred or Herrod [probably William Harrod] and served under Colonel George R Clark [George Rogers Clark] that she is unable to name the month or year when he entered said Service but supposes it was in 1777 or 1778, that the said Abraham Lienzader was with Colonel Clark at the taking of Kaskaskia that she has heard her said husband say that he had been while under Colonel Clark at Cauhow [probably intended to be Cahokia]¹, that he was stationed some time at a place which he called Port Vincent [probably Vincennes] that she is not able to state the time when her said husband left said service but believes that he remained in service as aforesaid for 2 years or more, She further states that her said husband served under Lieutenant John Swan some part of the time while he was in service as aforesaid, that she does not know of any documentary evidence in support of this application. She further declares that she was married to the said Abraham Lieuzadder on the 14th day of June in the year 1786, that her husband the aforesaid Abraham Lieuzadder died on the 14th day of December in the year 1826. That she was not married to him prior to his leaving the service but the marriage took place previous to the first of January 1794 viz.: at the time above stated.

[p 10: On June 23, 1846 in Guernsey County of Ohio, Jonathan Warne [? or Worne] gave testimony that his wife Patty Warne is a daughter of Abraham Lienzader and his widow Leah;

that he married Pattie on September 21, 1815; that he has made a family register which has been in his possession since 1850 except for such time as it has been in the possession of his sister Mary Warne of Guernsey County Ohio; that a family record shows that his wife was born in December 1791 but is not certain as to the day of the month but thinks it was December 17 1791

A Pay roll of Captain Joseph Bowman's Company of foot continued at the Illinois under the command of Colonel George Rogers Clark, commencing the 8th of August and ending the 14th of December 1778.

[p 31: On October 29, 1846 in Guernsey County Ohio, the widow filed a new application in which she describes her husband's services in more detail based on the records extracted above.]

[Facts in file: The widow died in Guernsey County Ohio June 6, 1850; the documents in the file do not disclose the names of the widow's parents or the date and place of her birth. In 1852 the children of the veteran and his widow were named as follows

Elizabeth Groves aged 64 years;

Mary Smith, born about 1790;

Martha or Patty, born December 17 or 26, 1791 married Jonathan Warne, September 21, 1815;
they had a son, Thomas, born in 1816;

Nancy Lieuzadder aged 58 years;

Rachel Bonnel aged 56 years;

Sarah Dougherty aged 54 years;

Isaac Lieuzadder aged 52 years;

Leah Martin aged 50 years;

John Lieuzadder aged 44 years

The following children survived their mother: Elizabeth Groves, Martha or Patty Warne, Leah Martin, John Lieuzadder and Isaac Lieuzadder

[Veteran's widow was pensioned at the rate of \$22.11 per annum commencing March 4th, 1836 for her husband's service as a private in the Virginia service.]
