Pension application of Thomas McMillan (McMillin) W2830 Mary McMillan f34VA

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

[p 7] Allegheny County State of Pennsylvania SS

On this 4th day of March 1839 personally appeared in the District Court in and for said County of Allegheny Mary McMillan a resident of Robinson Township in the County aforesaid aged seventy-three years who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed July 7th 1838, entitled "An act granting half pay and pensions to certain widows."

That she is the widow of Thomas McMillan who was a private soldier in the Army of the revolutionary war, – That she has frequently heard her husband the said Thomas McMillan relate his services as a soldier in the war of the revolution – that he served therein three years and six months part of which time was in the rifle Regiment commanded by Colonel Morgan [Daniel Morgan] – Deponent is now aged in years and has not a distinct recollection of things gone by and cannot therefore now state all the circumstances related to her by her said husband of his services in the revolutionary war: – Deponent however has heard him speak of being present at the battles of Ticonderoga [May 10, 1775], Stony Point [July 16, 1779] and other places.


This Deponent was married to said Thomas McMillan in the County of Allegheny and State of Pennsylvania as aforesaid in the year 1787 and that the marriage ceremony was performed by the Reverend Mr. Clark in the presence of witnesses but that no certificate of marriage was given nor was any entry of the marriage made in any record or book it not being customary at that time so to do: – That her husband the said Thomas McMillan died on the 8th day of June 1831. That she was not married to him prior to his leaving the service but the marriage took place previous the first of January 1794 viz.: at the time within stated. –

In witness whereof the said Mary McMillan appeared in open Court to let the District Court of Allegheny County as aforesaid on this the 4th day of March A.D. 1839, the said Court being a court of record and made oath to the foregoing.

[p 4: In the city of Pittsburgh, Allegheny County Pennsylvania John Young, 66, gave testimony that he is a brother of Mary McMillan, who married Thomas McMillan in 1787; that they lived together as man and wife until the death of Thomas McMillan in 1831; that his sister has remained a widow since that date; that he remembers hearing his brother-in-law speak of his service in the battles of Stony Point and Ticonderoga and other battles – that he served under Colonel Morgan; that he was in the service for 3 ½ years; that the deponent obtained a paper from the papers of Thomas McMillan which appears to be a commission for an Ensign in the

British Army which the deponent believes McMillan got whilst a soldier in the revolutionary Army.



[p 28: Affidavit given in Pittsburgh, Allegheny County, Pennsylvania by William Marks who testified that Thomas McMillan had the reputation in the neighborhood where he resided as being a revolutionary war soldier; that in the year 1818, the deponent was a member of the Pennsylvania legislature and presented a claim and papers of Thomas McMillan asking for a pension for his services in the war which application was approved and McMillan was given a pension of \$80 per annum for his services in the revolution. His affidavit is dated February 26, 1839.]

[p 32: Affidavit given by William McMillan, 72, the younger brother of Thomas McMillan; that he, deponent was present at the marriage of his brother to Mary his present widow; the wedding took place in Allegheny County in 1787; that his brother Thomas was an enlisted soldier in the revolution and served 3 years and 6 months under Captain Manny or Man; that his brother was selected and placed in the rifle Regiment commanded by Colonel Morgan and served therein under the command of Captain Van Swearingen. His affidavit is dated February 20, 1839 and was given in Pittsburgh, Allegheny County Pennsylvania.

[Veteran's widow was pensioned at the rate of \$80 per annum commencing March 4th, 1831, for her husband's service as a private in the Virginia Continental line
