Pension Application of Barrick Bryan W2993

Transcribed and annotated by C. Leon Harris

State of Kentucky

Henry County and Circuit Sct.

on this 5th day of September 1823 personally appeared in open Court being a Court of Record for the County of Henry & Circuit aforesaid, Barrick Bryan resident of said County of Henry and State a'd. aged seventy two years, who being first duly sworn according to Law, doth on his oath declare that he enlisted on the [blank] day of [blank] 1776 in the State of Virginia in the company commanded by Capt. Andrew Leach of minuit men, and was afterwards Towit on the [blank] day of May 1780 regularly enlisted during the war in the State of Virginia in the Virginia line in the Continental establishment in the Company commanded by John Anderson by Col. [John] Green, and by Gen'l Green [sic: Nathanael Greene] and that he served eighteen months and was then discharged at Salsberry [sic: Salisbury NC] on the 31 Dec'r. 1781 and that he was in the Battles of Gilford Courthouse [sic: Guilford Courthouse NC, 15 Mar 1781], and Campden [sic: Battle of Hobkirk Hill near Camden SC, 25 Apr 1781] and that he is a common labourer, and entirely unable to support himself and that he has only one child living with him towit Horster aged 14 years he believes – and that he stands in need of the assistance of his government. And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "an act to provide for certain person engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed.

NOTES:

A size roll compiled at Chesterfield Courthouse after 1 Sep 1780 includes the following: Barrack Bryan/ age 23/ height 5' 6"/ farmer/ born in Charles County MD/ residing in Prince William County VA/ black hair/ black eyes/ dark complexion/ enlisted 23 Sep 1780 for 18 months.

On 28 July 1843, Ann Bryan, near 73, of Trimble County KY, applied for a pension stating that her late husband, Barrick Bryan, lived in Prince William County when he enlisted, that as Ann Hancock she married him on 28 Aug 1788, and he died 4 Oct 1840. As evidence of marriage she submitted a family register transcribed below. The first page appears to be a clearer copy from the original two pages.
