Pension application of John Gaston W30007 Janet Gaston f24SC

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Illinois, Jefferson County

On this 12th day of September 1836 personally appeared before the Judge of the Court of Probate of the County and State aforesaid Jinnet Gaston a resident of Jefferson County and State of Illinois aged ninety-four years, who, being first duly sworn according to law, doth on her oath, make the following declaration, in order to obtain the benefit of the provision made the act of Congress, passed July 4th, 1836. That she is the widow of John Gaston Deceased late of Chester District State of South Carolina who was a private of the Mounted Militia under the Command of General Sumpter [sic, Thomas Sumter], That previous to General Sumter's organization he the said John Gaston performed seven tours of duty to suppress the collection of Tories and one tour of three months against the Cherokee Indians, Officers not recollected, that Captain McClure [John McClure] was the Captain he served on the first, and after he the said Captain Carr was killed, Captain Steel [John Steel] commanded, previous to the battle of Rocky Mount [July 30, 17801 he the said John Gaston was taken prisoner and in a few days paroled yet ventured to aid in that Battle of Rocky Mount and that at hanging rock [August 6, 1780] the Sabbath following where he had two brothers fall and one wounded, he had another Brother fall at Savannah as Captain of a regular Company -- That the said John Gaston being a quack doctor was employed by General Sumter to dress the wounds he the said General received at Broad River [Battle of Blackstocks, November 20, 1780], and was from that time with the person of General Sumter to the best of her recollection as a Surgeon till after the Battle of Eutaw Springs [September 8, 1781], when he was dismissed. That the said John Gaston was in 5 or 6 battles and skirmishes and was 5 years in the service of his Country without ever receiving a compensation.

She further declares that she was married to the said John Gaston previous to the revolutionary war. That the record of their marriage was lost when the British and Tories robbed them of nearly all their property. But that she recollects their 3rd child was Born the first day of January 1777. That she has no record of the services of her husband the said John Gaston. That he the said John Gaston her husband died some time in January 1808, and that she has remained a widow ever since that period as will more fully appear by reference to the proof hereto annexed.

What was sure maiden name? Ans: Jannet Knox

By whom were you married? Ans: By Father-in-law John Gaston Senior Esquire Of what complaint did your husband the aforesaid John Gaston die? Ans: the Influenza. S/ Jannet Gaston, X her mark

[Zadok Casey and Edward Maxey, a preacher of the gospel, gave the standard supporting affidavit as to the moral character of the claimant and the reputation of her husband as a revolutionary soldier.]

State of Illinois, Marion County

Personally appeared before me a Justice of the Peace of Marion County State aforesaid, William Gaston¹ Senior and after being duly sworn according to law saith That he the witness was acquainted with John Gaston Deceased husband of the applicant for the benefit of the provision made by the act of Congress passed July 4th, 1836 the now widow Jannet Gaston, previous to the revolution war. That before the marriage of the said John Gaston and Jennet Knox they lived on Fishing Creek Chester County State of South Carolina, they were married the fall of 1768. That the said John Gaston Deceased was a private in the mounted Militia under Captain McClure and the fighting Commenced sometime in the year 1774 and '75. That the first campaign was the Snowy Camps that after performing several routes they were regularly organized under General Sumter, before the Battles of Rocky Mount and Hanging-rock. That the said John Gaston was in those Battles and was a faithful soldier and a true Whig till the close of the war. That the said John Gaston had three Brothers killed and one wounded in that war and was once robbed by the British and Tories of nearly all their property. That the witness made their house his home from the organization of Sumter until after the war. That the said John Gaston has been dead about 20 years and that the applicant the widow Jannet Gaston of Jefferson County State of Illinois is the widow of the said John Gaston Deceased and never has been married again to any other person whatever.

[Veteran's widow was pensioned at the rate of \$20 per annum commencing March 4th, 1831 for her husband service as a private in the South Carolina militia.]


