[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

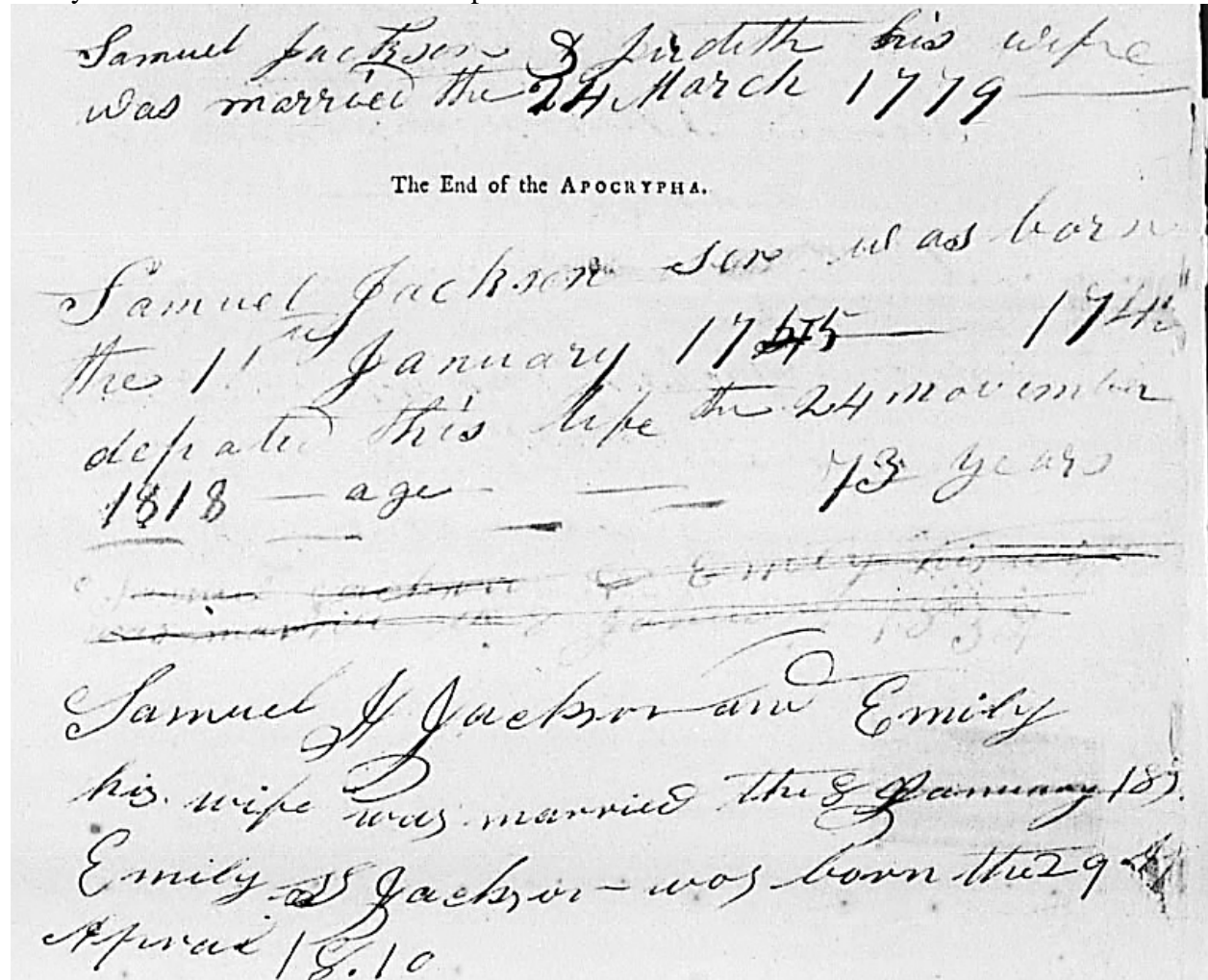

State of North Carolina, Granville County

On this 8 day of April 1844 Personally appeared before me E. Hester a Justice of the
 peace in and for said County Judith Jackson, a resident of said County and State aged 89 years
 who being first duly sworn according to law, doth, on her oath make the following declaration in
 order to obtain the benefit of the provisions made by the act of Congress passed July 4 day 1836
 that she is the widow of Samuel Jackson who was a private in the war of the revolution, and to
 the best of her recollection her said husband, entered the service in the year 1780 and in the years
 1780 and 1781, served four different towers [tours] of three months Each, three in the militia and
 one in Cavalry, the names of the officers she does not recollect but believes one tour was under
 Captain Henderson -- she further declares that she was married to the said Samuel Jackson on the
 24th day of March 1779 and that her husband the aforesaid Samuel died on the 24th day of
 November 1818, and that she has remained a widow ever since that period, as will more fully
 appear by reference to the proof hereunto annexed. Sworn to and subscribed on the day and year

State of North Carolina Granville County: April 12th day 1844

Personally appeared before me E Hester a Justice of the Peace in & for said County, Peter Cash,¹ a Resident of said County, aged, ninety years who being sworn deposeth & saith that he is acquainted with Judith Jackson, of said County and that he believes her to be the widow of James Jackson, deceased, who was a soldier in the war of the Revolution. That he served a tower [tour] of three months in the militia with said Jackson & that he Jackson was a private under John Henderson a Captain & John Quinn a Lieutenant which tower was towards the close of the war. Further this affiant saith not. Sworn & subscribed before me the day & year above written.

[p 10: On April 10th, 1844 in Caswell County North Carolina William Badgett gave an affidavit dated April 10, 1844 stating that he was a neighbor to the Samuel Jackson and his wife Judith and that they only had one child, a son named William.

[p 14, Copy of a marriage bond given by Samuel Jackson and William Hicks for Jackson's marriage to "Judah Hunt" in Granville County, NC; dated March 20, 1780. The bond is certified as a true copy by the clerk of the Granville County North Carolina Court of Pleas and Quarter Sessions.]

[p 31: Certificate dated September 4, 1844 issued by the Comptroller General of the state of North Carolina indicating that payments were made to a Samuel Jackson in 1789 for military services. He certifies that in all payments of 1 pound, 13 pounds 10 shillings and 20 pounds of shillings were made to Samuel Jackson.]

[Veteran's widow was pensioned at the rate of \$22.50 per annum commencing March 4th, 1848, for her husband service as a private in the North Carolina militia.]
