[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, Columbus County: Superior Court of Law Spring Term 1821

On this ninth day of April 1821 Personally appeared in open Court, being a Court of Record held in & for the County of Columbus Moses Taler an invalid revolutionary soldier aged sixty years, who being sworn on the holy Evangelist doth make the following declaration in order to obtain the provision made by the Acts of Congress of the 18th of March 1818 & the first of May 1820. That he the said Moses enlisted under Captain Daniel Williams¹ of North Carolina on Continental establishment sometime in the year 1777 or 1778 for the term of three years – which term he faithfully served (as he believes) in the fourth Regiment of North Carolina, or Colonel Armstrong's² North Carolina Regiment. He the said Moses does not recollect the exact date when he left the service but declares that it was a considerable time after the battle of Stono [Stono ferry, June 20, 1779] in which battle he fought under Captain Pill Taylor [sic, Philip Taylor, 5th NC Regiment], said Taler says he then served three months in the militia service & shortly afterwards enlisted under Captain Joseph T. Rhod [sic, Joseph Thomas Rhodes] of Continental establishment for the term of 18 Months – 11 Months of which period he served at or near Charleston South Carolina under Captains Raford [sic, either Robert or Peter Raiford] & Becot [sic, Peter Bacot, 1st NC Regiment] – when he was discharged at the declaration of Peace.

Said Moses Tyler further states that he is a farmer but unable to labor or maintain his family & that he has no income, that he is sick & deaf & dropaccal [sic, dropsical?]. He also states that he has no other evidence to prove his service except what is here annexed. And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or other wise disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled “an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war” passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed



Moses Tyler further declares that he has a Wife named Mary Tyler, aged about fifty – very little able to contribute to her on support, having been in a bad state of health for many years past, and two children viz. Tabitha aged about fifteen, who contributes as much to the support of the family of said Moses Tyler as could be expected from a female of her age – and John Jackson Tyler in the eleventh year of his age, whose health has always been bad.

[p 5: On November 7, 1841 in Columbus County North Carolina, Mary Tyler, aged 80 years, filed for a widow's pension under the 1836 act stating that she is the widow of Moses Tyler late of Columbus County; that she married him November 20, 1788 in Bladen County North Carolina; that they were married by William Goodman, Esquire, JP; that her husband died May 1, 1836; that she remains a widow. She signed her application with her mark.]

[p 53: facts stated in a letter summarizing the contents of the file: Soldier married in Bladen County (now part of Columbus County) NC, Mary Watts, daughter of Mary Watts who was still living in Columbus County, NC as of 1841.]
