Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky


Martin Johnston of Clarke County and State aforesaid came before me James Clark one of the Circuit Judges for the State aforesaid this 20th day of June 1818 and made the following statement upon oath for the purpose of obtaining a pension under an Act of Congress entitled an act "to provide for certain persons engaged in the land and naval services of the United States in the Revolutionary War." Being first sworn [he] makes the following statement: That he is at present a citizen of Clarke County and State of Kentucky – that he is by birth a Virginian. That he was two years a soldier in the war of the Revolution on Continental establishment. That on the 9th of February 1776 in Culpeper County Virginia he enlisted for the period of two years in Captain John Thornton's Company, Third Regiment Virginia line in the Continental establishment. That he faithfully served the two years and was on the eighth day of January February 1778 duly and regularly discharged at the Valley Forge Pennsylvania which discharge was issued by the Genl. Woodford [William Woodford] which discharge he has lost or misplaced so that at this time he cannot find it. He further states that he is about sixty-one years old and from infirmity he is incapable of labor and that by reason of his reduced circumstances in life, he is in need of sustenance from his Country for his support. The said Johnston further states that he can prove that he was a soldier as aforesaid by his Excellency James Monroe President of the United States who was part of the time Lieutenant of the company in which he belonged and was present with him at the battle of Trenton [December 26, 1776] where the said Monroe was wounded.

The following is the statement of William Wright¹ of Clarke County Kentucky aged about 67 years who being first duly sworn states that he has known the aforesaid named Martin Johnston from his early youth – That he knew that the said Johnston enlisted in Captain Thornton's Company, 3rd Regiment Virginia line for the period of two years agreeably to the foregoing statement of said Johnston. That he marched with the Army, and was absent for about the period of two years as he always understood, and as in part he knows, he the deponent being part of the time absent in the militia service. That during the two years in the year 1777 he the deponent joined the Army as a Militia man and was told by his [words written over and indecipherable] in the 3rd Regiment aforesaid – that the said Johnston had a short time before that been transferred to Morgan's Regiment of riflemen. That at this time he lived near neighbor to said Johnston and thinks that he is statement as to his reduced circumstances in life and he is living in need of assistance from his Country for support is correct and true.

[f p. 15: On November 25, 1839 in Clarke County Kentucky, Nancy Johnson, 77, filed for a widow's pension under the 1836 act stating that she is the widow of Martin Johnson, a revolutionary war pensioner; that she married him March 1, 1779 in Culpeper County Virginia; that she has no record of her marriage to him; that her husband died July 3, 1820 and that she has remained his widow. She signed her application with her mark.]

State of Tennessee Maury County

Be it remembered that on this 29th day of January 1840 before the Subscribers William H Wilkes & Taswell S. Alderman two of the Justices of the Peace for the County & State aforesaid personally appeared George Johnston aged about eighty-four years and being duly sworn upon the Holy Evangelist of Almighty God deposeth and saith

That Martin Johnston a brother of deponent sometime in the year 1777 in Culpeper County in the State of Virginia enlisted as a regular Soldier for the term of two years. When he first entered the Service the person that he was under the command of was by the name of John Thorn as well as I can now recollect. But before the two years expired he was attached to a Rifle company which was under the command of General Morgan [Daniel Morgan]. After he had served out the term of two years, that he had enlisted for he returned home, and married Nancy Wright – and was at some short time again drafted to another term of Service this term he did not perform in person but another man was hired by me in his place to perform his last tour for hire, for which I paid the man employed \$1000 in Continental money – during the whole time that my brother Martin Johnson [sic] was in the Army he was nothing but a private as well as I now recollect.

He was married about the 1st of March 1779 to Nancy Wright in Culpeper County in the State of Virginia. The names of his children were William Johnson, Francis Johnson and George W Johnston.

[f p. 48: On March 21, 1840 in Clark County Kentucky, Nancy Johnson, 77 on the 27th day of March last past, made application for a widow's pension under the 1838 act stating that she is the widow of Martin Johnson, a revolutionary war veteran who served some time under John Thorn a Captain; that he was attached to a Rifle Company Commanded by General Morgan; that after serving 2 years he was drafted as a militia man and was at the Battle of Kings Mountain [October 7, 1780]; she states that she married her husband in Culpeper County March 1, 1779. This Application was attested by William Hickman.]

[f p. 10: On April 28, 1840 in Clarke County Kentucky, William Johnson gave testimony in support of the claim of his mother Mrs. Nancy Johnson for a pension; he authenticates he belief or paper annexed

to his deposition has been torn from the Bible now in his possession which family Bible was given to him by his father Martin Johnson; that the first three entries in the record were made in the handwriting of William Wright who is now dead; that those entries show the marriage of Martin Johnson to Nancy Wright, the birth of this deponent William Johnson and Elizabeth Lawrence; that some of the other entries on the paper all in the handwriting of his brother George W Johnson now residing in Tennessee; and the balance of the entries are in the handwriting of the deponent; that his parents had 3 children, this deponent, Frances Johnson now the wife of John Johnson and George W Johnson.
