[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

The State of South Carolina, York District SS

On this 16 day of October A.D. 1832 personally appeared in open Court before the Hon. Wm. D. Master one of the Judge of the Superior Court of the said State, William McCarter, a resident of the State of North Carolina Lincoln County, aged seventy four years who being duly sworn according to Law doth on his oath Make the following declaration in order to obtain the benefit of the Act of Congress passed 7 June 1832.

That as well as he can recollect in the year 1775 he entered service of the United States as a militia soldier under the command of Col. Thomas Neil [sic, Thomas Neel], Capt. John Miller's [sic, John Mullen's] company against the Cherokee Indians that he was absent on duty this tour about two months. That he then resided in South Carolina in the present District of York. That he was in several engagements there with the Indians in the Indian Towns.

That he next served in the 1779—or thereabouts a tour of duty at Orangeburg in South Carolina that he was drafted to serve this tour commanded by Col. Thos. Neil [sic, Thomas Neel] & Major Hawthorne [James Hawthorn] in Capt. Byers [William Byers, Sr.] Company. Here he served for this tour three months, residing still in the same place.

The next tour of service was during the Revolution at the Four Holes in South Carolina where he went by command of Col. Hill [William Hill] & Col. Howe Militia Colonels who forwarded to him a Commission as Captain of the Militia. That under the Commission he acted as a Captain of Militia at the Four Holes for three months. That he cannot fix the year of his own recollection. That he was then residing at the same place & under the Military Command of Colonel Wm. Hill & Col. Jos. Howe [?]. That during this tour they had some skirmishing with the Tories.

The Next Tour of duty performed by him was under General Marion [Francis Marion], then Colonel Marion where he acted as a private & a volunteer on the Santee River, South Carolina below the Eutaw Springs. This duty was performed as well as he can recollect in the year 1779 and he was out during this tour two months.

That he also served other tours of duty in the Revolutionary War as a Whig Soldier of the Militia at various times but for what length of time he cannot recollect precisely but he can certainly say that it amounted to one year in addition to the forgoing services. That only for a few

days was the detachments he was in Service was connected with any regular troops and then only for a few days while at Bacon's Bridge near Dorchester who command the regular troops he cannot now remember—that he has now no discharges from service nor has he any documentary evidence of his services nor can he procure any that he is aware of—That he can prove his service by Capt. James Martin<sup>2</sup> and Robert Hannah [sic, Robert Hanna]<sup>3</sup>.

And that he does hereby relinquish every claim to any pension or annuity whatever except the present and declares that his name is not on the pension roll of the agency of any State.

The following questions were propounded by his Honor Judge William D. Martin to the applicant for a pension, on account of services as a volunteer in the Militia of South Carolina Interrogatory 1<sup>st</sup>: Where and in what year were you born?

Ansr: I was one in York County Pennsylvania on the 27<sup>th</sup> of January 1758

2<sup>nd</sup> Have you any record of you age and if so, where is it?

Ansr: I have the record of my age at my house in Lincoln County North Carolina 3<sup>rd</sup> Where were you living when called into service? Where have you lived since the Revolutionary War and where do you now live?

Ansr: When called into the service I resided in York District South Carolina; since the Revolution I have lived in York District South Carolina until within the last seven years, since which time I have lived in Lincoln County North Carolina.

4<sup>th</sup> How were you called into service; were you drafted; did you volunteer, or were you a substitute and if so for whom did you substitute?

Ansr: I first volunteered and was once afterwards drafted and every other tour I served I served as a volunteer.

5<sup>th</sup> State the names of some of the Regular Officers who were with the troops where you served, such Continental and Militia Regiments as you can recollect and the general circumstances of your service.

Anrs: I served under both General Lincoln [Benjamin Lincoln] and Green [sic, Nathanael Greene] Continental officers and General Sumpter [sic, Thomas Sumter] and Williamson [Andrew Williamson] Militia officers, I served in Colonel Neal's and Bratton's [William Bratton's] Regiments. The general circumstances of my service is stated in my declaration. 6<sup>th</sup> Did you ever receive a commission; and if so by whom was it given; and what has become of it?

Ansr: I did receive a commission signed by Colonels Hill and Howe – militia Colonels of South Carolina and after my tour of duty was over threw it away.

7<sup>th</sup> State the names of persons to whom you are known in your present neighborhood, and who can testify to your character for veracity and good behavior and your services as a Soldier of the Revolution.

Ansr: I am known in my neighborhood to the following Gentlemen who know me and believe I was an officer of the revolution to wit Wm Wilson, Esqr, Wm McGill, Esqr, John Oats and J. P. Montgomery.

Personally appeared before me the undersigned Justice of the peace &c William McCarter who being duly sworn deposeth and saith that by reason of old age, and the consequent loss of memory, he cannot swear positively as to the precise length of his service, but according to the best of his recollection he served not less than the periods mentioned below, and in the following grades; as a private he served in 1775 two months, in 1779 five months & in 1779 he served as a Captain of militia three months, and from that time until the end of the war he served as a private, during which time he served not less than twelve months making in all one year and ten months service, and for such service he claims a pension.

The following is the Amendment to the declaration of William McCarter for a Pension – first the reason I have not made my declaration in the County where I reside is as follows: The most of my Services was done in South Carolina and I have the best Opportunity of proving my Service in that State and it is only of a recent date that I moved out of the State and only lives two miles over the line and York Court House is nearest and Most Convenient to me and my greatest acquaintance with my Companions in Arms is there. –

I entered the Service as a private a Volunteer under the Command of Colonel Thomas Neil in the year 1775 and went against the Cherokee Indians was in the Battle at the Black hole<sup>4</sup> and Served in this tour three months, In the year 1779 I was drafted and Served in Captain Byers' Company Commanded by Colonel Neil and Major Hawthorn, Marched from York District to Orangeburg and was out in this Tour three months; In the same year 1779 I volunteered in Captain Peter's [John Petters'] Company commanded by Colonel Hill & Colonel Howe Marched to the Four Holes in South Carolina and was out three months. The above & last three months I served as a Captain but cannot prove being Commissioned and have lost my Commission. In the same year 1779, I volunteered as a private and Served under Colonel Marion a tour of two months was Stationed at Colonel Marion's residence on Santee River and was discharged at Bacon's Bridge, In June 1780 I Volunteered as a private Soldier in Captain James Martin's Company under the command of Colonel Sumter Marched to Clem's branch on the Catawba River and encamped then marched across the river and was in the Battle at Rocky Mount [July 30, 1780]<sup>5</sup> Where Colonel Andrew Neel & many others were killed and was in Actual Service until September 1780 Making a Tour of three months Was one of the guard of Colonel Sumter to Hillsboro to the Board of War where he was Commissioned Major General of the Militia of South Carolina<sup>6</sup> for the proof of the above and last mentioned Service I refer to the Affidavit of Captain Martin herewith filed, In the same year 1780 in December I was ordered and sent as a Military guard of Public Stores under Captain McCullough [William McCulloch] from South Carolina to New Bern in North Carolina returned in April 1781 was out in Service this tour of four months, for proof of the above and last mentioned Service I refer you to the Affidavit of Jacob Black and Robert Wilson herewith filed, in April 1782 I volunteered & served in Captain James Martin's Company Commanded by General William Henderson. Marched to Marshall's Mills on Congaree River from thence to Orangeburg encamped on Edisto River and was in Actual Service this Tour three months for proof of the above & last Service I refer you to the Affidavit of Captain James Martin here with filed.

That they the said deponent's in company with said William McCarter served as a Military Guard of public Stores under Captain William McCullough in a tour from South Carolina to New Bern in North Carolina that they left South Carolina in the month of December 1780 and returned in the month of April A.D. 1781 – That this tour was 4 months that the said William McCarter was in constant service during the said 4 months of which these deponents were eyewitnesses.




