[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of North Carolina Wake County }

On this 2nd day of March 1844 personally appeared before the Subscriber an acting Justice of the Peace in and for said County, Mrs. Ann Lewis, resident of Wake County, aged 80 years, who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefits of the provisions of the Act of Congress of the 7th of July 1838: -- That she is the widow of James Lewis deceased, a soldier of the Revolutionary War; that her husband the aforesaid James Lewis, served six months in the militia under Captain Matthew McCallers [sic, Matthew McCullers], of the County of Wake, in what year, she is unable at this remote period of time to state; she recollects distinctly that her husband went off in the service with him; -- and was gone the time above stated: -- That he afterwards enlisted and served twelve months in Captain Yarborough's [Edward Yarborough's] Company; that he enlisted a short time before the battle at Guilford [March 15, 1781] and went out and joined the Army immediately after that battle; she recollects distinctly the events of that time; and remembers them facts told her, by her husband, the said James Lewis of his service in the War of the Revolution: -- In his absence (during the war) this declarant resided with his mother, and consequently she has the better opportunity of knowing the length of his service; which, according to the best of her recollection, and the statements made by himself repeatedly, to others, compared to her statement as above: -- that she was legally married to the said James Lewis in the month of March 1783; in the County of Wake by John Whitaker Esquire; and that her maiden name was Ann Smith: -- that her husband the said James Lewis died in Wake County in the 29th day of December 1829, aged about Seventy one years; -- And that she has remained a widow ever since as will more fully appear by reference to the proof hereto annexed: --
