[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

State of Virginia Albemarle County: SS

On this 22<sup>nd</sup> day of October 1842 personally appeared before the Subscriber a Justice of the peace in and for the County aforesaid Margaret Jamieson a resident of Albemarle County and State of Virginia aged Ninety years who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 4, 1836; That she is the widow of Samuel Jamieson who was a soldier in the revolutionary war, and served several tours of duty in the Virginia Militia, during the revolutionary war; She does know that he was drafted at least five different times and she believes for two months each tour, She is unable now to give the particulars of each and every tour of duty but would referred to the testimony that will accompany her declaration; She is very certain however of his having served under the command of Captain John Miller in one of the tours of duty and under the command of Captain John Harris and under the command of Captain Henderson; She cannot now recollect the names of any other officers under whom he served the other tours; She further declares that she was married to the said Samuel Jamieson on \_\_ day of February 1769 (Several years before the revolutionary war), that her husband the aforesaid Samuel Jamieson died on the \_\_ day of April 1805 and that she has remained his widow ever since that period, as will more fully appear by reference to the proof hereto annexed. She has no record evidence of her marriage and does not know if any now can be found.


On this 22<sup>nd</sup> day of October 1842 personally appeared before me a Justice of the peace in and for the County aforesaid William Maupin<sup>1</sup> aged eighty-two years and made oath in due form of law that he was well acquainted with Samuel Jamieson the late husband of Margaret Jamieson (they were born and raised in the same neighborhood together) and he does well know that the said Samuel Jamieson was drafted and served at least five different tours of two months each in the time of the revolutionary war, for he the affiant served with the said Jamieson, he believes in each and every tour of duty that the said Jamieson served, but as he the affiant is now very old and his recollection does not now serve him to give all the particulars respecting the services of the said Jamieson, he would referred to his own declaration, and the testimony of accompanying

the same now in the files in the pension office to prove the services of the said Jamieson as he does know that they served together nearly each and every tour that he the said affiant served. Affiant further states that he believes that the said Samuel Jamieson served one tour of duty below Richmond under the command of Captain John Miller, and he does know that he served one tour of duty under the command of Captain John Harris in this tour of duty they were stationed in the neighborhood of Williamsburg and Yorktown, and he believes that he served another tour of duty under the command of Captain Bennett Henderson; his memory will not permit him to state the names of the other officers; but he is very certain that he served at the lowest 5 different tours of duty [image of this page cuts off at the bottom thereof] [next page] and affiant does know that said Samuel Jamieson and Margaret Jamieson lived together as man & wife and always acknowledged each other as such to the day his death. Affiant further states that the said Samuel Jamieson died on \_\_ the day of April 1805, and that the said Margaret Jamieson has never married since the death of her said husband but still continues his widow to this period.

State of Virginia Albemarle County: SS

On this 3<sup>rd</sup> day of November 1842 personally appeared before me a Justice of the peace in and for the County aforesaid Micajah Bowen<sup>2</sup> aged eighty-nine and made oath in due form of law. That he was well acquainted with Samuel Jameson and he does well remember that the said Samuel Jameson was drafted and served a tour of two months duty in the revolutionary war in this tour of duty he marched from the County of Albemarle under the command of Captain \_\_\_ Burke [John Burke] in the month of February 1781 and marched down through Richmond, Williamsburg, Yorktown & down to Hampton and was stationed at Hampton three weeks and was marched back to Yorktown; and thence to Richmond and was discharged at Richmond having served out the two months tour of duty. Affiant states that in the above named tour of duty he was under the command of Colonel Lindsey [Reuben Lindsay], affiant further states that the said Samuel Jameson was again drafted in the month of May in the same year for another tour of two months duty and marched from the County of Albemarle under the same Captain Burke in this Second tour of duty they marched from the County of Albemarle in Virginia to the City of Richmond and then back to the County of Orange to the Raccoon Ford in the County of Culpeper and thence back to Richmond and was discharged in Richmond on the last of June, having served out this Second tour of duty of two months, he was still under the command of Colonel Lindsey as commander of the Regiment and General Nelson [Thomas Nelson] was his Commander in Chief, affiant further states that he served with said Samuel Jameson and belonged to the same Company in both of the foregoing named tours of duty and affiant further states that in the foregoing named tours of duty the said Samuel Jamieson served as a soldier.

On this 5<sup>th</sup> day of November 1842 personally appeared before me the Subscriber a Justice of the peace in and for the County aforesaid Hannah Maupin aged 68 years and made oath in due form of law that she is the daughter of Samuel Jamieson and Margaret his wife, and she does well remember that her Father the said Samuel Jamison did serve several tours of Militia duty in the time of the revolutionary war, She is very positive that he served at least 3 tours of duty (if

not more) for she does know that he was very frequently in the service towards the latter part of the war, Affiant is unable to state now the particulars of the service which her father performed as she was at that time very young.

State of Virginia Albemarle County to wit

The deposition of William Maupin Testifies that he is eighty-three years of age, and that he was well acquainted with Samuel Jamieson the late husband of Margaret Jamieson (whose maiden name was Margaret Craig) and he is very certain that the said Samuel Jamieson served four or five different tours of duty as a soldier of two months each in the same company and under the same officer him deponent, in the militia during the Revolutionary War, and tour of duty they were drafted in and marched from the County of Albemarle State of Virginia to the lower part of Virginia viz. to Richmond, Williamsburg, York Town & to the neighborhood of Hampton, deponent cannot now relate all the particulars of each tour of duty in consequence of loss of memory and old age, but he does well know that the said Samuel Jamieson served one tour of duty under the command of Captain John Miller, and he believes he served a Second tour of duty under the same Captain John Miller, he well recollects that Captain John Miller served three different tours of duty in the time of the revolutionary war: and he deponent did serve two tours of duty himself under the command of Captain John Miller, and he believes that Jamieson served both the tours with him, the said Jamieson served another tour of duty under the command of Captain John Harris, he served another tour of duty under the command of Captain Bennett Henderson and he believes that he served another tour of duty under the command of Henry Burke, deponent further states that whilst in the service with said Jamieson they were under the command of Colonels Ennis [James Innis], Mathews [perhaps Sampson Mathews] and Reuben Lyndsey and other field officers, not now recollected deponent cannot now recollect whether he has named the captains, and colonels in regular order as the service occurred, but he does know that the officers named above did command the said Jamieson and himself; neither can he give the particular years in which the tours of duty named above were performed in but he believes they were performed in the years of 1780 and 1781. Deponent would refer to his own declaration now on file in the pension office in support of his deposition; deponent would further state that he lived a very near neighbor to Samuel Jamieson ever since he could first recollect and he does well remember when he the said Jamieson returned from the Parsons after his marriage with Margaret Craig, the said marriage took place in the year 1772 or 1773.

[Veteran's widow was pensioned at the rate of \$33.33 per annum commencing March 4<sup>th</sup>, 1831, for her husband's service as a private for 10 months in the Virginia militia.]
