[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Georgia, Lincoln County

On this the Twenty Sixth day of November 1855 personally came before me B. F. Tatom [Benjamin F. Tatom] a Judge of the Ordinary Court for and in said County & State, a Court of Record, Milly Glaze, aged Ninety years, who being first duly sworn according to Law doth on her oath make the following declaration in order to obtain the benefit of the provision of the act of Congress, passed July 7th, 1838. She declares, that, she is the widow of Thomas Glaze, late of Lincoln County Georgia, deceased, who entered the Army of the United States in the Revolutionary war in the year 1776, and the County of Granville, State of North Carolina, Hillsboro District, that he served a tour of three months & then was drafted for three months & served it out, & then he entered for the war & continued to the end of it, & he was at Blueford's [sic, Buford's] defeat [Battle of the Waxhaws, May 29, 1780], & other places probably, which her infirm age will not allow her to remember. And she further declares, that, he was a private in said war, and, she has no recollection of the name of his Captain, but, she thinks he was under a Colonel Murray, but, she is not sure.

And she further declares, that she was married to the said Thomas Glaze, her husband, in the County of Granville, N. C., on the Thirtieth day of December 1782, by Parson Micklejohn, and, the result of that, marriage was twelve children, whose births are hereunto annexed. And she further declares and says, that, she & her husband came to Georgia after the war and settled in Lincoln County, that, her said husband died in this County on the 13th day of February 1805, and she has remained here, a widow ever since that period. And she further declares, that no family record exists of the marriage of herself, or, the death of her husband, or births of her children. And she hereby refers to the proof heretofore sent to maintain the death of her husband, her widowhood, and, their marriage relations. Sworn to and subscribed before me, the day and year above written.

[p 15: On March 14, 1856 in Lincoln County Georgia, Samuel Glaze, 62, gave testimony that he was born November 22, 1793 as informed by his mother Milly Glaze; that William, David, Sarah, Margaret, Tandy and Samuel Glaze brothers and sister of this deponent were older than this deponent, Samuel having died in infancy and this deponent was named Samuel also and that Asa, John, Mary, Elizabeth and Thomas Glaze his brothers and sisters were younger than this deponent.

[p 15: On March 14, 1856 in Lincoln County, Mary Glaze, 58, also gave testimony in which she states

[Note: Widow, Milly Glaze died August 1, 1856 in Lincoln County, Georgia survived by five children, William, Thomas, Samuel, Mary and Sarah Cornelison (formerly Glaze).

p 10: Milly attested to the above at age 90 on 26th Nov. 1855. She stated that the record of the birth of the children has been lost and the above is to the best of her recollection.]

[p 5: Certificate filed in Lincoln County Georgia in January 1757 that Milly Glaze of said County departed this life at the residence of Thomas D Cullars, High Sheriff of said County on August 1 1856; Cullars testifies that he was present when she died; that she left 5 children surviving, William, Thomas, Samuel, Mary and Sarah Cornelison, formerly Sarah Glaze.]

[Veteran's widow was pensioned at the rate of \$64.31 per annum increased from \$46.66 per annum for her husband's service as a private in the North Carolina service. Her initial pension of \$46.66 was commenced on March 4th, 1836.]

[Note: The file of Austin Godsey R21991 (Virginia veterans) contains the application for bounty land

filed by Milly Glaze in Lincoln County Georgia; said application is dated July 30, 1855; in this document she describes her husband's services as follows: "Thomas Glaze went into the Revolutionary Service against Great Britain from Hillsboro District, Granville County, North Carolina as a private, substitute in the month of April or May in the year 1776 and served a tour of 3 months after which the said Thomas Glaze was discharged and returned home to the place of his enrollment after which the said Thomas Glaze again went into service as a drafted man and after his 2nd tour of service the said Thomas Glaze volunteered and served during the war at which time he was discharged, that he was at Blufords defeat, that his service was mostly in North & South Carolina that from the long period of time and the age and subsequent loss of memory of deponent, she does not recollect what Captain or Colonel the said Thomas Glaze was under...". This file also contains a power of attorney executed by the widow by which she authorizes her attorney to receive her land bounty in her behalf. She signed up both documents with her mark.]
