[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Tennessee Williamson County

The declaration of Caty Foley October 16th day A.D. 1839

I Caty Foley after being duly sworn depose and say as follows -- viz.: I was married to Mason Foley as well as I remember in March 1772 in Caswell County North Carolina, by whom I had 7 children the names and ages of which will be shown attached to this by a copy from the family record, my husband Mason Foley removed from North to South Carolina about the year 1779 he was appointed Captain of the tenth company in the Spartan Regiment as will more fully appear from the enclosed commutation—my husband Capt. Mason Foley was in the battle at the Cowpens [January 17, 1781]. I have no certain recollection of any other particular battles he was in but he was out for several years on scouts in various directions, we were robbed and plundered by the Tories of nearly all we possessed.

We returned to North Carolina Caswell County and lived there a term of years and then removed back to South Carolina and lived there until the death of my husband, which took place in the year 1802 on his journey to the North and I was informed by my son Washington G. L. Foley, who was with him at the time.

I have remained his widow from the time to the present never again been married. From the best information I can get 6 of my children are yet living -- further this deponent saith not --



[p 19: John Foy, 55, likewise gives a supporting affidavit stating that he knew you Caty and Mason Foley when they lived in North Carolina, he was at that time a boy living in Halifax County Virginia & that he was acquainted when in Virginia with Henrietta, Delpha & Washington, children of Caty and Mason; and afterwards came to know Nicey, Parazedy and Narcisus. He signed his affidavit with his mark.]

[p 19: Henry Gray, 67, likewise gave a supporting affidavit saying he knew Caty and Mason Foley in Caswell County North Carolina and several of their children. He signed his affidavit with his mark.]

State of Tennessee Williamson County

On this 8th day of September 1840 -- Personally appeared in open Court Caty Foley of the County and State aforesaid, aged Eighty Five years and one month, who first being duly sworn according to law, doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed the 4th July A.D. 1836 That she is the widow of Mason Foley who was a Captain in the militia of South Carolina in the Spartan Regiment and rendered services during the years Eighty & Eighty-one [1780 & 1781] and further services in scouts, but how long she cannot tell and he was in the Battle at the Cowpens she knows of him being in no other battles. She further declares that she was married to the said Mason Foley on the 26th day of March 1772, and that her husband the aforesaid Mason Foley died in the month of March 1802 [could be 1812] in Pittsylvania County Virginia as I was informed by my son Washington G L Foley, and that she has remained a widow ever since that period, as will more fully appear from the references to the proof.

[p 10: Alexander Moore gave testimony in Williamson County Tennessee on September 8, 1840 that he took the original family record of the Mason Foley family consisting of one leaf and marked A from a Book of Common Prayer.]

[p 20: On November 10, 1851 in Davidson County Tennessee, Stephen Foley, 37, a resident of Williamson County, Tennessee, filed a claim stating he was the administrator of the estate of Caty Foley stating that Caty Foley was a pensioner up to the date of her death which occurred on November 9 1840, that she died leaving the following surviving children and heirs at law Delpha Foley, Narcissa Butrey, Nicy Warren, Elza Moss and Pargada Broughton.

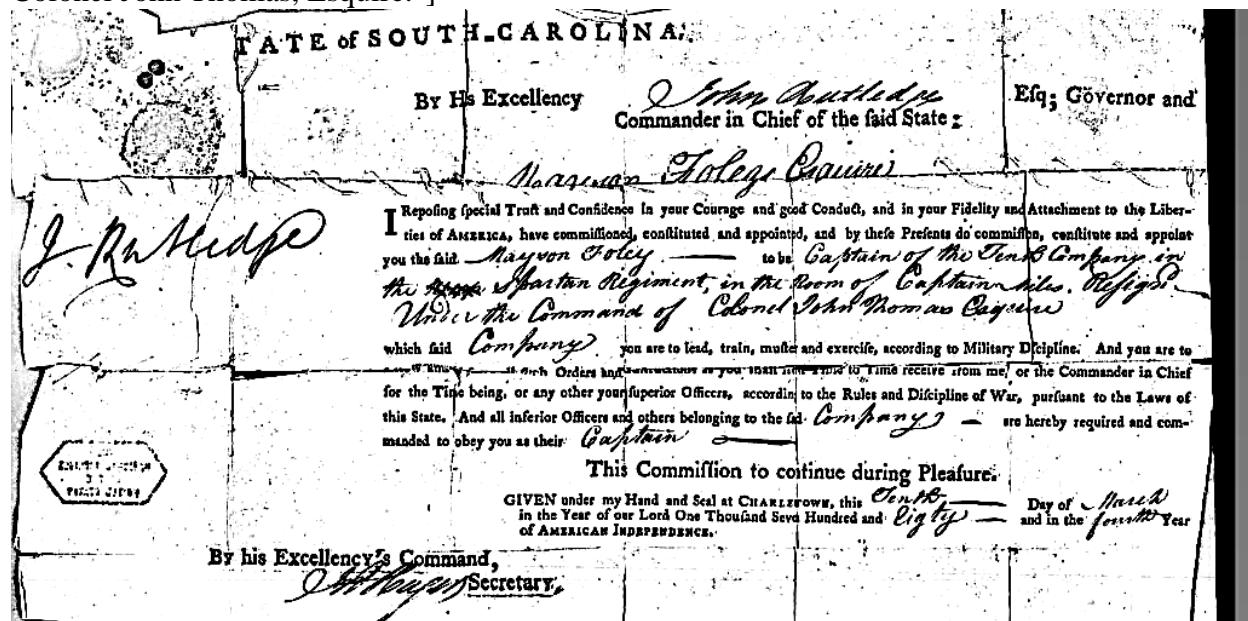
To service done as Capt. at different times in the Spartan Regiment sometimes on foot and some time on horseback under the command of Gen. Williamson, and after the fall of Charleston under Capt Hon. General Sumter, from 13 day of February until 14th day April 1780 on foot 30 days at 60/ £90.0.0

And from 19th day of August 1780 until the 1st day of April 1781 225 days on horseback at 70/ pr day £787.10

[p 38 is the original of the captaincy commission granted to Mason Foley signed by John Rutledge Governor and dated March 10, 1780. It designates him "Captain of the Tenth Company in the Spartan Regiment in the Room of Captain Miles, Resigned, Under the Command of Colonel John Thomas, Esquire."]



[p 42, Stephen Foley states that he is guardian and son of Delpha Foley, one of the surviving children of Caty and Mason Foley.]

[Veteran's widow was pensioned at the rate of \$188 per annum commencing March 4th, 1831, for her husband's service for 9 months & 12 days as a Capt. in the South Carolina militia.]
