Pension Application of Joseph Golloday W7555

Transcribed and annotated by C. Leon Harris

District of Virginia SS

On this 27th day of October 1819 before me the subscriber one of the Judges of the general Court of Virginia personally appears Joseph Golloday aged 61 years resident in Shenandoah county in the said district, who being by me first duly sworn according to Law, doth on his oath, make the following declaration, in order to obtain the provision made by the late act of congress, entitled "An act to provide for certain persons engaged in the Land and naval service of the United States in the revolutionary War" That he the said Joseph Golladay enlisted in Woodstock in the state aforesaid in the year 1776 in the company commanded by Capt. Jonathan Clark of the Reg't. 8th Virginia that he continued to serve in the said Corps or in the service of the United States untill the year 1779 when he was furloughed in Fredericksburg state of Virg'a afore'd that he was in the battles of German Town [Germantown 4 Oct 1777], Brandywine [11 Sep 1777] and Monmouth [28 Jun 1778] and that he is in reduced circumstances and stands in need of the assistance of his country for support and that he has no other evidence now in his power of his said services but the affidavit enclosed

John Bly [sic: John Bly, pension application S37780] and Joachim Fetzer [S39518] personally appeared before me Hugh Holmes a Judge of the General Court of the State aforesaid and made oath that Joseph Golladay an applicant for a pension enlisted in the year 1776 in the comp'y commanded by Capt'n Jonathan Clark 8th Virg'a Regiment then commanded by Colo afterwards Gen'l Mughlenburg [sic: Peter Muhlenberg] continental line, that he served in that Regiment more than nine months - the said Joachim was a messmate of said Golladay - that said Golladay afterwards enlisted for three years or during the war. Given under my hand this 27th day of October 1819

This day Colo Jacob Rinker [First Lieutenant in Capt. Jonathan Clark's company] of Shenandoah County appeared before me Hugh Holmes a Judge of the General Court of the state afore's and made oath that he is well acquainted with John Bly and Joachim Fitzer who have given an affidavet as to the revolutionary military services of Joseph Golladay and knows them to be men who ought to be believed on their oath and has no hesitation in adding that they are credible witnesses Given under my hand this 26th day of October 1820

Virginia to wit

On this 23 day of April 1821 personally appeared in open Court being a Superior Court of record for the County of Shenandoah, Joseph Golloday aged 63 years who being first duly sworn according to Law, doth on his oath make the following declaration in order to obtain the provision made by the acts of Congress of the 18th of March 1818 and the 1st May 1820, that the said Joseph Golloday enlisted for one year in the fall of the year 1776 in the state of Virginia in the company commanded by Captain Jonathan Clark in the regiment commanded by Colonel Nevil [sic: John Neville] in the line of the state of Virginia on the continental Establishment that he continued to serve in the said corps for about 2 years when it was commanded by one ___ Kilpatrick [possibly Capt. Abraham Kirkpatrick], and that he afterwards served about one year when he was furloughed and returned home where he was taken sick and never afterwards returned to the Regiment. That he was in the battles of Brandywine, Germantown and Monmouth, and that he has no other evidence in his power except the affidavits of John Bly, Joachim Fetzer and Jacob Rinker heretofore forwarded
And in pursuance of the act of the 1st of May 1820 I do solemnly swear that I was a resident citizen of the United States on the 18th day of March 1818, and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an Act of Congress entitled "An act to

provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed. 9 acres of poor Land, 1 set of Smiths tools, 3 pewter basons, 1 pewter platter 6 pewter plates one 10 gallon gattle, one iron tea kettle, one griddle, one dutch Oven, 1 set of cups and saucers, 1 coffee pot, 4 tin cups, 1 table, 1 doz pewter spoons, 1 iron pot, 1 churn, 2 split bottom chairs, 1 pr steelyards, one chest, one whiskey keg, one iron Ladle and flesh fork 1 axe & 1 shovel. I have about four pounds due to me and owe £2.16.4 my trade is a blacksmith but owing to my extreme old age I am unable to follow it. my wife aged 68 years, lame with the Rheumatic pains and myself live with my son in Law Henry Lickliter [or Lichliter] Joseph Golloday [Adam Lickliter made oath that the value of the property was not more than \$91.]

NOTE: On 16 Mar 1839 Mary Golloday, 86, applied for a pension stating that as Mary Huslender she married Joseph Golloday in 1784 in New York state, and he died in Sep 1826. On 5 June 1843 she certified that she was still his widow. Henry Lickliter, 51, submitted a family record copied into his Bible from that of Joseph Golloday which was burnt in 1827 He stated that his wife, Susannah Golloday, was the second child of Joseph and Mary Golloday. Other documents state that the oldest child was Jacob Golloday, who was 54 in 1839. Lewis Lickliter and John Lickliter also witnessed Mary Golloday's application.

Henry Lickliter was born Sept th 14 day 1787

Susannah Golladay was born Sept th 10 day 1787

Mary Heulsland[edge of page] was born Jan th 22 day 1753

Henry Lickliter march the 13 day 1839 [date record was taken from Bible]

Malalatel Lick[edge of page] was born Sept th 27 day 1822

Rebecca Lickliter was born oct th 19 day 1825

Anna Magdalena was born July th 26 day 1827

Sarah Lickliter was born oct th 17 day 1829

Rosilla Lick was born Dec th 10 day 1832
