[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Virginia Stafford County: SS

On the 13th day of October 1838 Sarah Jones a resident of said County aged seventy-eight years personally appeared before me, a Justice of the peace in the County aforesaid and being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed July 7th 1838, entitled "An Act granting half pay and pensions to certain Widows" That she is the widow of George Jones who was a private of Infantry in the Army of the revolution, that he enlisted in King George County Virginia in a company commanded by Captain Wallace [possibly Andrew Wallace of the Virginia Regiment under the command of Colonel Abraham Buford which on May 29, 1780 was defeated by British forces under the command of Lieutenant Colonel Banastre Tarleton at the battle of the Waxhaws] in the year 1778 for three years, as she always understood from said Jones her husband, and marched to the South and reached Charleston South Carolina shortly after the Capitulation of the American Army at that place; after serving out his term of three years she states that, she understood from her said husband, that he became the substitute of James Crop in Stafford County Virginia and was at the Siege of York in 1781 and marched with the British prisoners to Winchester Virginia; and that she never heard him speak of any other service during the War of the Revolution. She further declares that she was married to the said George Jones on the 25th day of February 1784 by the Reverend John Koons in the County of Shenandoah Virginia; that her husband the aforesaid George Jones died on the 10th day of October 1812; that she was not married to him prior to his leaving the service, but the marriage took place previous to the first day of January 1794, viz. at the time above stated.

This day personally appeared before me a Justice of the Peace for the County aforesaid James G Watson a Respectable Witness now in his 65th year of age and made oath before me that he was for many years during the lifetime of George Jones acquainted with him as also with his wife Sarah Jones to the present day, that this Affiant further says that his the said affiant's father was a private soldier during the whole or much greater part of the Revolutionary War and that he often heard his said Father say that the said George Jones was a Regular Soldier during said War or that he served 3 years in said War as a Regular Soldier. Given under my hand and seal this 18th April 1839

State of Virginia Culpeper County to wit

On this 17 day of October 1838 personally appeared before me a justice of the peace in and for the said County John Hall in 78th year of his age and doth declare upon oath to the following facts, that he was well acquainted with George Jones Deceased of Stafford County who was a soldier in the American Revolution that he marched with the said George Jones Deceased from Fredericksburg Virginia to Winchester to guard some British prisoners.

[p 5: certificate given by the clerk of the Shenandoah Virginia court saying that among the records in his office is one reflecting that on February 25, 1784 John Koons returned the names of George Jones and Sarah Williams on the list of marriages.]

[Veteran's widow was pensioned at the rate of \$80 per annum commencing March 4th, 1836, for her husband service as a private for 2 years in the Virginia service.]
