## District of Kentucky Sct

On this 16<sup>th</sup> day of July 1818 before me the subscriber one of the Circuit Judges for the district afores'd personally appeared James Pritchett aged 55 years and resident in Burbon [sic: Burboun] County in the said District, who being by me first duly sworn according to Law Doth on his oath make the following declaration, in order to obtain the provision made by the late act of Congress entitled "an act to provide for certain persons engaged in the land and naval Service of the United States in the Revolutionary war"; That he enlisted in the Service of the United States in the year 1779 in the state of Virginia the Captain of the Company he cant recollect but it was in Colo. Davis [sic: William Davies BLWt597-500] regiment of Fottmen [sic: footmen, i.e. infantrymen] in the continental establishment and remained in the sevice about nine months at the expiration of said time he reenlisted in Captain or Lieutenant Francis Dade's [BLWt606-200] Troop of Horse belonging to Colo William Washingtons Regiment of Light Dragoons, During the war and served in said Regiment untill the close of the war and was Discharged in 1783 at Nelsons Ferry on Santee river, South Carolina. That he was in the Battles of The Cowpens [17 Jan 1781], Guilford [Guilford Courthouse NC, 15 Mar 1781], Cambdin [sic: Battle of Hobkirk Hill near Camden SC, 25 Apr 1781], Eteau [sic: Eutaw Springs SC, 8 Sep 1781] - Ninety Six [siege of Ninety Six SC, 22 May - 19 Jun 1781] and many skirmishes. That he received a wound in his right leg at the Battle of the Eteau spring. That he is in reduced circumstances and needs the assistance of his Country for support and that he now offers all the evidence now in his power of his said services.

On this twenty day of August in the year one thousand eight hundred and twenty, personally appeared in open Court, being a Court of record in and for the Circuit aforesaid, James Pritchard aged about fifty eight years, resident of Bourbon County, who being duly sworn according to law doth on his

oath declare that he served in the Revolutionary war as follows, to wit, three years and four months, nine months in the infantry under Capt. [Joseph] Scott of as well as he can remember the number, of third Virginia Regiment of the Virginia line, then the residue of the time in the troops of Francis Dade of the third Virginia Regiment of Light Dragoons commanded by Colo. Will Washington, as detailed in his original declaration dated the 16 July 1818 now on file in the War office, by virtue of which he is inscribed on the pension list roll of Kentucky agency, of which he has received a certificate dated 13 Feb'y. 1819 – No. 6684 And he did solemnly swear that he was a resident Citizen of the United States on the 18 March 1818 and that he has not since that time by gift sale or in any manner disposed of his property or any part thereof with intent thereby so to diminish it as to bring himself within the provisions of an act of Congress entitled "an act to provide for certain person engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18 day of March 1818 and that he has not nor th has any person in trust for him any property or securities contracts or debts due to him nor has he any income other than what is contained in the Schedule hereto annexed except his bedding, wearing apparel, & his pension from the United States

For the purpose of obtaining the benefit of "an act for the relief of ceratin surviving Officers and Soldiers of the Army of the Revolution approved the 15<sup>th</sup> March 1828 I James Prichard in the County of Bourbon in the State of Kentucky do hereby certify that I enlisted in the Continental line of the Army of the Revolution for and during the War and Continued in its service until its termination at which period I was a private Soldier in Captain Bowyer Company (and I think then Commanded by Francis Dade) in the third Regiment of light Dragoons of the Virginia line, Commanded by Colo. William Washington, and I also declare that I afterwards received a certificate for the reward of eighty dollars to which I was entitled under a resolve of Congress passed the 15th day of May 1788 And I do further declare that I was not on the 15<sup>th</sup> day of March 1828 on the Pension list of the United States [18 Dec 1828]

NOTES:

A size roll compiled at Chesterfield Courthouse after 1 Sep 1780 includes the following: James Prichett/ age 17/ height 5 81/2/ farmer/ born and residing in Stafford County/ light-brown hair/ hazel eyes/ dark complexion/enlisted 23 Sep 1780 for 18 months.

On 23 Nov 1838 Phebe Pritchard, 75, applied for a pension stating that she married James Pritchard in Culpeper County VA on 28 Dec 1788, and he died 28 June 1833. As proof of marriage she submitted her original family register transcribed below. The family register was certified by two men who also deposed that Phebe Pritchard had been a member of the Baptist Church for about 38 years and was

then a member at Elizabeth Meeting House.
