Be it known that on the 15<sup>th</sup> day of September 1837 personally appeared before the undersigned a justice of the peace in and for the county of Jefferson and state of Kentucky Frances Field, a resident of the city of Louisville in said county & state, aged about seventy three years, who being first duly sworn according to law, doth on her oath make the following declaration in order to obtain the benefit of the provisions of the act of Congress of the United States passed July 4, 1836 and of the act explanatory of said act passed 3<sup>rd</sup> March 1837. That she is the widow of Reuben Field, who was a Captain in the Army of the Revolution and served as follows as she verily believes. That said Reuben Field was residing in Culpepper [sic Culpeper] County State of Virginia and entered the service of the United States in the 8<sup>th</sup> Virginia Regiment as a private in Captain George Slaughter's Company, of which company Henry Field [Henry Fields] and George Kertley [possibly a misidentification of Lieutenant James Kirtley] were Lieutenants & John Graves Ensign. This was in the Spring of the year 1776. The said regiment was commanded by Col<sup>o</sup> Peter Muhlenburg [Peter Muhlenberg]. They were marched to Norfolk & Suffolk in Virginia and then to Charleston in South Carolina. That he remained in the service as a private until some time in the year 1777 when he was appointed Captain in the army of the Revolution in the Virginia line on Continental Establishment and continued in

Said service until the close of the war in 1783. During the time of his service the said Captain Reuben Field was taken prisoner by the British and confined in Philadelphia for a considerable time. She has no documentary evidence in her possession proving the service of said Captain Reuben Field and she has to rely on the only proof she can now procure which is hereto attached.

She further declares that she was married to the said Captain Reuben Field (whilst he was in the service as aforesaid) in the County of Fauquier State of Virginia on the 2<sup>nd</sup> day of June 1782 by Parson Craig as a minister of the gospel by publishing the bond of matrimony as well as she recollects & believes and she has been informed that marriages performed in that manner were not recorded. That her husband the said Captain Reuben Field died in the month of April 1815 in Bourbon County State of Kentucky and that she has remained a widow ever since that

period. The only evidence she can now present of her marriage and of the death of said Field is hereto annexed and to which she refers.

Be it remembered that on this first day of September 1837, personally appeared before the undersigned a justice of the peace in and for the county of Spencer in the state of Kentucky, Bryant Sloan, who being first duly sworn, states that in the Spring of the year 1776 himself and Reuben Field & many others entered the service of the United States (in the Revolutionary War) in the Company commanded by George Slaughter of the 8<sup>th</sup> Virginia Regiment then commanded by [paper damaged and word obscured by an ink blot] Peter Muhlenburg, Henry Field & James [paper damaged and last name of skewered by an ink blot] were the Lieutenants and John Graves Ensign of said Slaughter's Company. That they were marched to Norfolk & Suffolk & thence ordered on & marched to Charleston in South Carolina. That said Reuben Field continued to serve as a private until some time in the year 1777. The said Field was appointed a captain in the service in the said Virginia line and was there in the service when this affiant in the fall of the year 1779 came to the western country and remained here until the fall of the year 1780 when he returned to Virginia and he found that said Reuben Field was still in the service as a Captain and said Field so continued in the service until the close of the war in 1783 as well as he now recollects & believes. State of Kentucky Jefferson County: Sct.

Be it known that on this 27<sup>th</sup> day of October 1837 personally appeared before the undersigned a justice of the peace in and for the County & State aforesaid Frances Field resident of the City of Louisville in said County & State, aged about seventy-three years, who being first duly sworn according to law, doth on her oath make the following additional Declaration in order to obtain the benefit of the provisions of the Act of Congress of the United States passed July 4, 1836 and of the act explanatory of said Act passed 3<sup>rd</sup> March 1837. That she is the widow of Captain Reuben Field who served in the Revolutionary Army as is stated in her foregoing Original Declaration. That she was married to the said Captain Reuben Field in the County of Fauquier in the State of Virginia on the 2<sup>nd</sup> day of June 1782. At the time of the marriage aforesaid the said Captain Reuben Field was on a visit to his relations & friends – he then belonged to the Army & presumes he had obtained a furlough. A very short time after the said marriage he returned to the Army and served (occasionally visiting home) until the close of the War in November 1783 having served about one year & five months after his said marriage she verily believes it was in the month of November 1783 when said Field returned home from the Army.






## Reuben & Abraham Field

Reuben Field as a Captain allowed one year, eight months and fifteen days above six years in the Continental line – the Representatives of Abraham Field who died in service allowed the bounty of a private in the same line for the war.

## Application for Bounties in Land

If Reuben Field continued in service to the end of the war of which I have no reason to doubt, he was in the Continental Army seven years eight months and fifteen days, and has been allowed (according to the within Certificate) for no more than three years service. Abraham Field having died in service, I would suppose that his Representatives are entitled to the Bounty in Lands.



It appears by the books of this office that a certificate from the executive bearing date the first April 1783, a warrant for 4000 acres issued, the same day, to Reuben Field in consideration of his services as a Captain of the Virginia Continental line for three years ending the 10<sup>th</sup> of March 1780. No other warrant appears to have issued for the services of said Field Land office

I Jonathan Clark Lieutenant Colonel in the Eighth Virginia Regiment in the Revolutionary War do Certify that Captain Reuben Fields [sic] was a soldier in Captain George Slaughter's Company in the Eighth Regiment commanded by Colonel Peter Muhlenberg in the month of March 1776, but how long before that, he had enlisted I know not. That he was afterwards promoted in that Brigade to an officer, that he continued in that until the battle of Germantown [October 4, 1777], when he was made prisoner – at this time he was a Lieutenant – I was then in the same Regiment. This Regiment commanded by Colonel Muhlenberg was at first the 8<sup>th</sup> Regiment it was about the year 1778 annexed to the 4<sup>th</sup> Regiment and with that became the 4<sup>th</sup> Regiment – This much I certify of my own knowledge – I was taken prisoner at Charleston [May 12, 1780] and I believe before Captain Fields was exchanged – I have always understood that Captain Fields was exchanged afterwards – that he again joined the Army and continued in it the end of the War before which he was promoted to a Captaincy.
