[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina, Pickens District

On this the first day of October in the year 1832, personally appeared in open court, before the Honorable Richard Gantt, in the Superior Court of Sessions and, Common Pleas now sitting in Pickens Court House, John Thrift a resident of the State and District aforesaid, aged seventy-three years on the 6th of January next, who being first duly sworn according to law, doth on his oath make the following declaration, in order to obtain the benefit of the act of Congress passed the seventh of June A.D. 1832

To wit; The said deponent entered the service in the Revolutionary war as a volunteer, and serve two campaigns, as hereinafter stated, both taken together amount to some small time over six months of actual military service. First, the said deponent entered as a volunteer some short time before the Battle of Kings Mountain [October 7, 1780] under the following officers, himself being a common soldier, -- Col. Benjamin Cleveland, Lieutenant Colonel Joseph Herndon, Major Hartgrove, Major Benjamin Herndon and Captain Abram Moore, other officers not remembered. That, further, said deponent was a resident of North Carolina. That he started from Wilkes Court House, crossed Catawba River then Green River, then Broad River at the Cherokee Ford. Col. Cleveland had gone on ahead of the foot soldiers and in command of his Horse, was present at the Great Battle of Kings Mountain and returned with some hundreds of British soldiers and Tories taken at Kings Mountain. Colonel Cleveland, met his Army of Foot at the Cherokee Ford, on Broad River. The deponent John Thrift was amongst the Foot soldiers who met Colonel Cleveland at the Cherokee Ford. Said deponent with the Army marched back and carried the prisoners taken at Kings Mountain to Housertown [sic, Hausertown]¹ afterwards he was discharged from service, having been three months in the Service.

Again, one year or thereabouts after the battle of Kings Mountain, this deponent, John Thrift, entered the Service of the common cause of American liberty, as a volunteer, under the following named officers: General Rutherford [Griffith Rutherford], Major Thomas Magure (or Macquire) Captain Thomas Morris and 1st Lieutenant James Ireland. We took up arms when the Army assembled at Salisbury. Was living then in Rowan County, N. C. -- marched from Salisbury to Finsdales [?] Ferry on Pee Dee [sic, Pedee River], was stationed near the Pedee about two weeks made several marches along Pedee in quest of Tory parties and was engaged in checking and keeping them down, during which time we crossed the Cape Fear River about 20 miles below the mouth of Cross Creek during this second Campaign under General Rutherford this deponent was some time more than three months in actual military service as a volunteer,

before he was discharged, and the Army broke up. Both campaigns make the time amount to some more than six months of service under arms.

The deponent hereby [relinquishes] every claim whatever to a pension or annuity except the present and declares that his name is not on the pension Roll of the Agency of any State.

State of South Carolina, Pickens District

Personally appeared, before me the undersigned, a Justice of the Peace &c John Thrift of the said District who has applied for a Pension under the act of Congress of June 7th 1832 – and being duly Sworn, deposeth and saith, that he was born near Petersburg in the State of Virginia on the 6th day of January 1760 as he has been informed by his parents: That he has no record of his age – That at the time he was called into the service he lived in Wilkes County in the State of North Carolina – during the war he moved into Roan [sic, Rowan County] & lived in it till it was divided he was in Iredell at the division & lived there till the year 1804. He then moved to York District in South Carolina lived there six years till 1810 – when he moved to Union District in this State where he lived 12 years till 1822. -- he then moved to Pendleton District, & has lived in that part of Pendleton now the Judicial District of Pickens for the last 11 years. He is very poor, infirm and illiterate, a memory much impaired, with a wife very much afflicted, he has got at so great a distance from his companions during the Revolutionary War, that he does not know of a single living witness, there is none that he has heard of or can procure. He is personally acquainted with Colonel Joseph Grisham, Col. David McKinney who commanded the Regiment he lives in Lieutenant Colonel Jesse McKinney of 1st [illegible], Jesse Neville,² who is a near neighbor & who says he is satisfied that I was at the Battle at King's Mountain from many circumstances which he knew to be as related, as we have often conversed about our troubles during the Revolutionary War.

Also acquainted with William L. Keith the Clerk of the Court – and William B. Sloan the Sheriff of the District of Pickens. And confidently upholds to all to whom he is known as he does not know any man who would not willingly testify to his credibility.

[p 11: On October 10, 1844, Elizabeth Thrift of Pickens District, South Carolina, filed for a widow's pension stating that she was about 94 or 95 years old; that she was the widow of John Thrift who served under Captain Morris in Col. Cleveland's Regiment; that they lived in Caswell, Rowan, Wilkes and Iredell counties in North Carolina at different times and afterwards moved to Union District South Carolina and from thence to Pickens District 23 years ago; it's that she married John Thrift near Grassy Knob in Wilkes County North Carolina, the marriage was performed at Squire Sanders by a Baptist minister by the name of Petty; that they were married in March of 1781; and that her husband died on August 2, 1840. Further she states as follows:

“She also declares further, that she has no record of her marriage, nor does she know that she ever had it, but if so, in moving about so much from place to place it is lost; she presents

herewith, an old slip of paper containing a record of the births of a portion of her children, amongst which will be found recorded, "Mary Thrift was born October the 4th day of the year of our Lord 1784." Which was her second child; Elizabeth Thrift being her oldest, was born near three years before the birth of Mary; her birth was recorded in an old Prayer book by one Peter Smith which book is lost by some means or other in her rambles. The births of Marthey (as it is written) and Mary Thrift, as shown by the record of the slip of Paper herewith sent, was recorded by one Alexander Whitaker, and this said slip has been in her care ever since, kept in an old Testament."

[Veteran was pensioned at the rate of \$20 per annum commencing March 4, 1831, for service as a private for 6 months in the North Carolina militia. His widow was pensioned in a like amount.]
